## <u>TERMS AND CONDITIONS FOR</u> <u>THE WILLOWBROOK HIGH SCHOOL CRAFT FAIR</u> <u>TO BE HELD ON</u> <u>SATURDAY, OCTOBER 20, 2018</u>

## IN CONSIDERTION FOR ACCEPTANCE AS AN EXHIBITOR FOR SAID FAIR, THE EXHIBITOR HEREBY AGREES TO ABIDE BY THE FOLLOWING TERMS AND CONDITIONS:

- 1. Willowbrook High School/The Willowbrook Parents Organization (WPO)/Julie Nilles and each of their respective managers, agents, volunteers or employees shall not be responsible for any loss or injury to the exhibitor, its agents or employees for personal injury or any other injury from any causes whatever to the persons of the exhibitor's business or for damage to or theft of the exhibitor's goods or property, including but not limited to vehicles, exhibits, products, equipment and other personal property. The exhibitor agrees to hold Willowbrook High School/The Willowbrook Parents Organization/Julie Nilles and each of their respective managers, agents, volunteers and employees harmless from any liability arising out of his/her exhibiting at said show.
- 2. Willowbrook High School/Willowbrook Parents Organization (WPO)/Julie Nilles, all sponsors and facilities and each of their respective managers, agents or employees shall not be responsible for any failure of the exhibitor to obey Federal, State, or local laws or ordinances or for any loss or injury to the public caused by exhibitor, its agents, employees or grounds of the facility also known as Willowbrook High School. The exhibitor agrees to hold Willowbrook High School/The Willowbrook Parents Organization (WPO)/Julie Nilles and each of their respective managers, agents, volunteers and employees harmless from any such liability arising out of her/his exhibiting at said fair.
- 3. Willowbrook High School/Willowbrook Parents Organization (WPO)/Julie Nilles provides no insurance on the property of the exhibitor or against the acts or omissions of the exhibitor, its agents, or employees. All insurance for personal property and public liability must be carried by the exhibitor.
- 4. Spaces are rented on a first come first serve basis. Refunds can only be issued prior to the deadline date <u>and</u> only if space is resold or unless the fair is filled when the exhibitor's fee and application are received. If the Willowbrook High School Craft Fair should not be held for any reason, this agreement shall terminate and the exhibitor waives any claim for damages except return of rental fee. Rented space areas shall not be subleased, nor shall any person other than the accepted exhibitor occupy or exhibit at the rented space. All names shall appear on the application. Those operating otherwise shall be refused rental space at current and future shows.
- 5. Police and fire regulations must be observed. No parking in fire lanes. Vehicles may be ticketed and towed at owners' expense. If electrical connections are available, all electrical connections require a multi-outlet strip with circuit breaker and surge suppressor. Please bring an extension cord and power strip; we do not supply them.
- 6. Exhibitors will leave premises in a clean condition, removing all garbage/waste of any kind prior to leaving. Any damage to structure, property, or the premises arising out of acts or omissions of the exhibitor, its agents volunteers or employees shall be paid for in full by the exhibitor as determined by Willowbrook High School/The Willowbrook Parents Organization (WPO)/Julie Nilles and manager/s of Willowbrook High School.
- 7. Distribution of advertising materials on the premises is NOT permitted without prior approval of Willowbrook High School/The Willowbrook Parents Organization (WPO)/Julie Nilles. By signing/dating the application you agree to give promotional consent to Willowbrook H.S./The Willowbrook Parents Organization (WPO)/Julie Nilles to use your name and/or the name of your business on maps and other materials used for the purpose of increasing foot traffic before and during the fair.
- 8. Unload as quickly as possible. Do NOT block doorways. Move vehicles immediately to exhibitors parking area. Do NOT set up while unloading.

9. This agreement shall be governed by the laws of the State of Illinois. If any provision of this agreement is determined to be unenforceable, the remaining provisions shall remain in full force and effect.
