EDUCATIONAL FOCUS ITEMS

English Department Common Core Standard Presentation

The English department chair from both schools presented the common core standard implementation process and the writing initiatives in both schools. The English teachers have worked to create a District 88 writing rubric that is aligned to the Common Core and is now being used across the English classes as well as the other content areas. All English classes 9-11 have been aligned to the Common Core English Language Arts standards and both buildings are using the same common assessments to ensure that all students are gaining the skills they need to be college and career ready. Writing is being incorporated throughout all content areas and with the use of Mastery Manager, longitudinal data is now being collected on D88 student progress towards the writing standards.

Rising Star Report

Mrs. Barbanente reported on the district's progress with the Rising Star Comprehensive Plan as it relates to the district/school improvement plan. Main focus is on curriculum: alignment to common core, cohesion between both buildings, and a completed online curriculum guide by 2015.
