◇ **Public Hearing on the 2016 Tax Levy**

The proposed tax levy for 2016 was reviewed during the October 31, 2016, and November 14, 2016, Board meetings. During the November 14, 2016, meeting, the Board adopted a resolution to establish the aggregate amount of taxes estimated to be levied for the year 2016 in the amount of \$54,031,186. That request represents a 4.9-percent increase, but we expect to receive an increase of about 1.0 percent based on the CPI at 0.7 percent and limited new-property growth. Because the value of total property and new property is unknown at this time, the district levied higher. No changes or updates were made since the proposed tax levy was approved in November. In compliance with the Truth in Taxation Law, a notice was published on December 7, 2016, that public comments would be heard at the December 19, 2016, meeting. The public hearing was opened during the December 19, 2016, Board meeting for Board members and audience members to ask questions and discuss the 2016 proposed tax levy.

◇ **Educational Focus Items**

Assistant Superintendent Mrs. Jean Barbanente and Director of Curriculum, Instruction & Assessment Mr. Adam Cibulka provided an overview of the results students will receive from the fall PSAT exam through CollegeBoard's Khan Academy. Superintendent Dr. Scott Helton reported the analytics will provide both the student and the district with important information such as strengths and where to improve.

Mr. Cibulka also shared the summer school programming for June 2017 has been revamped to assist with keeping students on track for graduation and providing opportunities for students to accelerate their learning and earn additional credits during the summer.

Bond Refunding Results Series 2016

Chief Financial Officer Mr. Edward Hoster introduced Ms. Jennifer Currier from PMA, who shared the new Series 2016 bonds were sold to refund the Series 2007 and advance refund of the Series 2008 bonds for a total of \$73,070,000. The total gross savings is \$12,554,414, and on a net present value basis, the savings equates to \$10,593,867, which exceeded the target of \$10 million. The drop in debt service amounts to an estimated reduction of \$63 for a \$300,000 home in the 2016 tax year and \$33 a year in subsequent years until the bonds are paid off in 2028.
