PBIS and Bully Prevention Update

Mrs. Barbanente along with Assistant Principals Mr. Mike Bolden (AT) and Mr. Sam Bentsen (WB), along with PBIS Internal Coaches Erica Craig (AT) and Bryan Murphy (WB), presented behavior data and ongoing initiatives of Positive Behavior Interventions and Supports (PBIS) since it was introduced in the spring of 2007. "Blazer Pride" and "The Warrior Code" represent the school culture created by teaching student expectations. Over 25 local and regional high schools have visited the campuses to learn about best practices district wide.
