# **Educational Focus Items**

#### ESL/Sheltered Program

Mrs. Barbanente reviewed and defined the meaning of ESL, Bilingual and Sheltered classes. She provided information on the state school code requirements for the above programs and the challenges District 88 faces in light of state requirements. She then turned the program over to Mrs. Barb Willson, Literacy Department Chair at Willowbrook High School, and Mrs. Jenna Phillips, ESL Department Chair at Addison Trail High School. Their presentation included an explanation of each course offered in the program and data was provided to support the success of the program. Dr. Humphrey stated we may need to get more politically involved to help our legislators learn of the need for policy change in relation to the state requirements for our ESL, Bilingual and Sheltered programs.
