#### **Recognition of District 88 Successes**

##### 88's Best Students

88's Best Students Huda Siddiqui from Addison Trail and Hiba Mirza from Willowbrook were recognized for the month of September. The students were congratulated on their many accomplishments. The students thanked the Board, their teachers and their families for support.

##### Instructional Showcase

District 88 Transition Program Teacher Stephanie Nitka, along with Learning Services Coordinator Jack Andrews, showcased various activities the program has implemented to engage students during Remote Learning. The District 88 Transition Program helps individuals ages 18 to 21 who have disabilities learn life skills, obtain job training in a community setting and transition to life after District 88.

#### **Public Hearing- Fiscal Year Budget 2020-21**

A public hearing took place on the budget for 2020-21.

Dr. Helton recognized the work Mr. Edward Hoster, District 88 Chief Financial Officer, his team, and the Finance Committee put forth in preparing and reviewing the budget.

Mr. Hoster reported the projected deficit for the tentative budget was (\$1,447,665) and the final budget reflects a deficit of (\$1,549,261). Revenue changed from tentative to final with a net decrease of (\$737,132) primarily due to the ongoing pandemic and the move to a remote learning model. Revenues for food sales and rental of facilities were the primary changes. Expenditures changed by a reduction of (\$635,648) primarily driven by expected decline for cafeteria service management and transportation service reductions.

#### **Educational Focus Item**

Yvonne Tsagalis, Assistant Superintendent for Curriculum and Instruction, continued to highlight the components of Every Student Succeeds Act (ESSA) in connection to the District 88 missions and vision. Mrs. Tsagalis focused upon student participation in extracurricular activities and shared the district's overall participation rates.
