Credit Card Summary

Chief Financial Officer Mr. Edward Hoster reviewed the district's credit card use report for June 2018, as outlined in Board Policy 4:55 Use of Credit and Procurement Cards.

Overview of 2017-18 Financial Report (Unaudited) as of June 30, 2018

Mr. Hoster presented the unaudited cash basis Financial Performance summary and analysis reports for the 2017-18 fiscal year. He provided information summarizing a comparison of "budget to actual" revenue and expenditures for 2017-18, reviewing the Operating Funds. The district was able to minimize the budget deficit (\$1,189,004) to close the fiscal year with a net increase to total Operating Fund Reserves of \$4,653,948, which includes the advance early property tax payments and the 2015 bond proceeds. The auditors will be completing their accounting adjustments this fall to establish the accrual basis financial position for the fiscal year.
