# Man injured in Monday night shooting at Lombard gas station

A 21-year-old man sustained a gunshot wound Monday night outside a Lombard gas

According to Lombard Police Chief Ray Byrne, the DuPage County Sheriff's Office received a call at about 8:14 p.m. on Dec. 7 advising that a subject had been shot in the leg. Officers were able to get a general location of the caller, who was near Finley and Roosevelt roads. At that point, both Lombard and Glen Ellyn police were dispatched to the area as it is on the borderline of both villages.

Byrne said Lombard police also received a phone call from Advocate Good Samarian Hospital in Downers Grove advising that there was a gunshot victim at the hospital reporting that he had been shot at the Mobil gas station located at Finley and Roosevelt roads in Lombard.

Lombard detectives and officers were sent

to both the gas station and the hospital. Officers were able to interview the victim at the hospital, who related that he was meeting someone at the gas station, and an altercation ensued with the male subject allegedly pulling out a gun. Byrne said one bullet reportedly was fired. The bullet hit the 21-year-old man in the buttocks.

"We do not believe this was a random act and do not feel there is any danger to the public at this time," Byrne said Tuesday morning.

Officers and investigators at the gas station located fresh blood on the east side of the building, Byrne said, adding that the blood comborated that some type of injury had taken place there.

On Tuesday, the incident remained under investigation as Lombard detectives continued to actively work the case with the DuPage County State's Attorney's Office. Anyone with information about the incident is asked to contact Lombard police at 630-873-4400.

**DuPage Forest** Preserve offers flurry of winter fun Go sledding. snow tubina. ice fishing. cross-country skiing and more

WHEATON - From ice fishing to snowshoeing to cross-country skiing, the For-est Preserve District of DuPage County gives residents plenty of reasons to get outside and

play this winter.

When there's plenty of snow on the hill (usually more than 3 inches), thrill-seekers can snow tube down the 800-foot run on Mount Hoy at Blackwell Forest Preserve in Warrenville. The rental area is open 9 a.m.-4 p.m. on weekends Dec. 5-Feb. 28 and the following school holidays: winter break, Dec. 21-Jan. 1 (except Dec. 25); Martin Luther King Jr. Day Jan. 18; and President's Day Feb. 15. Inner tube rentals are \$5 per day (\$7 for a nylon tubes) and end at 3:30 p.m. Only district tubes are allowed.

Visitors can also explore the forest preserves with rented snowshoes. Rentals are \$8 for two hours or \$13 per day and are available when there's ample snow on the trails.

When Mount Hoy's open, rentals are available at the base of the hill until 2 p.m.

Visitors can also rent daily 10 a.m.-2 p.m. at Fullersburg Woods Nature Education Center in Oak Brook. Call 630-850-8110 for availability.

For fans of cross-country skiing, rangers groom more than 70 miles of trails at forest preserves such as Blackwell, Fullersburg Woods in Oak Brook, Danada and Herrick Lake in Wheaton, Greene Valley and Springbrook Prairie in Naperville, Mallard Lake in Hanover Park, Meacham Grove in Bloomingdale, Waterfall Glen in Darien and West DuPage Woods in West Chicago.

Visitors who aren't classic skiers should use the inside of the trails to avoid damaging the set tracks.

Ice fishing, ice skating and sledding are allowed at most forest preserves, although never at Spring Creek Reservoir in Additionally, Bloomingdale. sledding is not allowed at Mount

# Willowbrook wrestling team poised for success

Warriors return pair of state runners-up in Rowland and Jessen

How many high-school wrestling teams can say they have a pair of state runners-up in their lineup?

The answer is not many. But for the Willowbrook wrestling team, the answer to that question is two.

The Warriors return secondplace state finishers in senior Matt Rowland (University of North Carolina signee) and sophomore Jack Jessen.

"Not too many teams have two state finalists in their lineup," said Willowbrook coach Brandon Murphy. "This is a team that I have been excited about for a long time. The team is led by a strong group of seniors that have a lot of varsity experience. Sprinkled in the lineup are a lot of new faces to the varsity team. But the young guys come in here with a lot of experience Many of them have wrestled numerous years in the youth program. That experience is paying off and they are jumping right in and competing well."

Through late last week the Warriors were off to a 13-1 overall start which included

winning the 10-match Vernon Hills team tournament and also scoring a 54-25 West Suburban Conference Gold Division win over defending conference champion and district neighbor Addison Trail.

"This team has tremendous potential and when all guys are healthy, this team could scare and compete with a lot of teams in the state," said Murphy "And with it being Illinois wrestling that means anyone in the country."

Rowland, who went 47-3 last year, was 13-0 through late last week at 170. Jessen, who went 49-3 a year ago, also was 13-0 at 182. Jessen was a double national runner-up in freestyle and Greco this past summer and already is a four-time All-American.

"Matt has always been well-balanced, he is an excellent student and will leave Willow-brook as the winningest wrestier in school history," said Murphy. "He works hard every day and is the leader of the team. He always is trying to improve and never settles on past performances. Jack is coming off one of the most impressive freshman seasons in state history. This year he is moving up a weight and is focusing on improving his wrestling. He already is technically sound,

but he is perfecting the little things that will add to his ability to attack. Jack is a machine that just keeps coming. He has a motor that always is in high gear. This is contagious and when the rest of the team sees how hard he trains, they know why he is successful."

Also back for the Warriors are seniors Andrew Verr (113, sectional qualifier a year ago), Trevor Bell (120, 12-1 currently), Noah Nagle (152, 13-0 currently), Elijah Rochel (195, 12-1) and Jake Wozniak (heavyweight, 8-5 currently), along with junior Marcus Kupicizowicz (heavyweight) and Dominic Ranieri (126,

10-3 currently).

Elijah was out last year with an injury," said Murphy. "He was a starter for us two years ago and I believe he is going to be able to compete with anyone by the end of the season. The entire team has been patiently waiting for his return and he hasn't disappointed. Trevor is on a mission. He spent the summer training at one of the toughest training camps in the country (J Robinson camp). Trevor came back a different kid. He is focused and ready to reach his goals this season.



#### Jumpstart Your Health begins in January

ELMHURST - Edward-Elmhurst Health is offering Jumpstart Your Health to help community members make lasting changes to reduce their risk of type 2 diabetes.

According to the Centers for Disease Control, 37 percent of U.S. adults (51 percent of those 65 and older) have a condition called pre-diabetes, which means a person's blood glucose (sugar) level is higher than normal but not high enough to be diagnosed as diabetes. However, it may lead to type 2 diabetes, which can cause heart attack, stroke, blindness, kidney failure, and circulatory problems.

A person may have pre-diabetes if they:

- Are 45 years of age or older; Are overweight;
- · Have a family history of type 2 diabetes;
- Are physically active fewer than three times per week;
- Had diabetes while pregnant (gestational diabetes) or gave birth to a baby that weighed

more than nine pounds.

Jumpstart Your Health is a year-long program that incor-porates lifestyle changes to help prevent or delay type 2 diabetes. The program stresses weight loss and moderate physical activity, which has proven successful in preventing or delaying diabetes in people who have or are at risk for pre-diabetes.

The program will be offered at several locations beginning in January. There is no fee for participants thanks to support from the Elmhurst Memorial Hospital Foundation and grant funding from the Lions Club International Foundation, Lions District 1-J and Elmhurst Lions Club. The program is part of the Centers for Disease Control and Prevention's National Diabetes Prevention
