Villa Park police arrest Giendale Heights man after ATM heist

Villa Park police responded for an activated alarm at a tobacco shop early Saturday morning to find the ATM had been stolen.

Officers responded to Uncle Tobacco, 140 W. North Ave., at about 5:54 a.m. on May 7 to find the burglar alarm sounding and the front window of the business smashed, according to Villa Park Police Detective Sgt. Bill Lyons.

The front of the business had been damaged and an ATM had been removed, Lyons said.

He added that officers were able to quickly view surveillance video, from which they were able to get a description and license plate number.

Lyons said a short time later Elmhurst police stopped a vehicle matching the suspect vehicle near I-290 and North Avenue.

Although the driver reportedly attempted to flee on foot, he was taken into custody. Lyons said the ATM was located in the van, which had been stolen out of Northlake. Along

with the ATM, officers recovered an undisclosed amount of cash from the ATM.

This burglary comes less than two weeks after another ATM heist in Villa Park, which occurred during the early morning hours of April 26.

On April 26, police responded to Casa del Vino, 137 E. North Ave., at about 5:13 a.m., where they discovered damage to the store front.

At the time, Lyons said an unknown subject(s) removed the ATM from the liquor store

The ATM was located a couple of blocks away, minus an undisclosed amount of cash, according to Lyons.

Michael J. Pouliezos, 47, with a last known address in Glendale Heights, reportedly confessed to both burglaries, Lyons said.

Pouliezos was charged with two counts of burglary and possession of a stolen motor vehicle. He was transported to DuPage County Jail in Wheaton, where as of press time, he was being held in lieu of \$200,000 bond.

Lombard man dies after drug overdose; police chase suspect

Lombard police were called to a home on the north side of the village last week, where a Lombard man lost his life apparently to a drug overdose.

At about 2:30 p.m. on Wednesday, May 4, officers responded to a single-family residence in the 500 block of North LaLonde, according to Lombard Police Detective Cyndy Velazquez.

Officers found a deceased 39-year-old man inside the home, the victim of an apparent drug overdose.

"We suspect a heroin overdose due to what was found at the scene," Velazquez said, adding that this will not be confirmed until the results of toxicology tests come back.

While detectives were still on the scene later in the day, a 2002 Pontiac Bonneville pulled up to the home at about 9:30 p.m., the lieutenant said.

Two detectives, wearing plainclothes, approached the vehicle with the intention of speaking with the occupants. The driver of the vehicle took off, with police following in marked and unmarked vehicles. Once the detectives realized, the officer in the marked squad had backup, the detectives pulled off the pursuit, Velazquez said.

A police department press release states that officers attempted to conduct a traffic stop on the Pontiac, when a chase ensued.

Lombard police were assisted by other police agencies as the pursuit went eastbound on 290 into Chicago.


Lombard officers terminated their pursuit near Congress and Lower Wacker, but the release states that the pursuit was then taken over by the Chicago Police Department and Illinois State Police. The driver of the vehicle did manage to elude police.

The 2002 Pontiac was found hours later abandoned in Bensenville. No suspect(s) was located at that time.

The vehicle was brought to the Lombard Police Department. According to Lombard Police Detective Jason Chudzinski, detectives obtained a search warrant, and with the assistance of the DuPage County Major Crimes Task Force evidence crew, the vehicle was searched and processed for evidence.

On Monday, Lombard detectives were still following up on a number of leads. Velazquez said officers saw at least two occupants in the Pontiac

Sousa's super sectional includes all-around title

Willowbrook sophomore Adam Sousa won the all-around championship at Friday's IHSA boys gymnastics sectional at Glenbard West Sectional in Glen Ellyn. Sousa compiled an all-around score of 53.80 at the nine-team sectional. That score represents a total of Sousa's finishes on six separate events. Sousa earned first-place finishes in two events—the horizontal bar and the pommel horse. He placed alone in second in two other events-floor exercises and the vault-and tied for second on the still rings. Sousa delivered a fifth-place effort on the parallel bars.

Sousa's all-around score of 53.8 was more than two points ahead of the runner-up in the sectional's allaround competition. Junior Timmy Le of Glenbard West was the event's allaround runner-up with a score of 51.45. No one in the state's four other sectional competitions earned a better all-around score than Sousa. The second-best sectional effort came from Dundee-Crown senior Satchel Hudson, who turned in a 53.25 to win the all-around title at Saturday's sectional at Palatine High School.

Sousa will compete in this Friday's all-around competition at the IHSA state meet at Hinsdale Central High School. The all-around and team competitions at the state meet will take place on Friday, while the individual event contests take place Saturday. All gymnasts who earned top-five sectional finishes in an event

automatically qualified to compete in the state meet. Sousa earned automatic berths in all six events.

Sousa's sectional-winning routine on the horizontal bar earned a score of 8.85, which was a full point higher than the runner-up in the event. Sousa secured his other victory on the pommel horse-his final event of the evening. Sousa's routine on the pommel horse produced a score of

"I enjoyed the high bar," said Sousa of his winning performance on the horizontal bar in his fourth event of the sectional. "I thought that was pretty good for me. I was also happy with floor [exercises—his fifth event of the night]. I tweaked my back a little bit on the high bar. I kind of pinched a nerve, so I was definitely pretty sore going into my floor routine, but I had to fight through it." Sousa added that the pommel

horse event wasn't as stressful on his back as the floor routine. While the pommel horse routine marked the end of Sousa's night of competition, he still had to make seven trips to the medal stand, where awards were handed out to the top five finishers in each event, as well as the top five allaround finishers.

Sousa's performance in floor exercises yielded a second-place score of 9.45. His effort on the vault picked up a runner-up score of 9.35. Sousa's score of 8.55 on the still rings





making things happen," Cronin said. "It is making foundational changes that will begin to turn this ship around.

"This may seem like little stuff, but in DuPage County, we have already seen savings of \$100 million."

Illinois Comptroller Munger takes the floor

"Illinois has not had a balanced budget in 15 years. We must have a budget. We are at the precipice and right now, we are being governed by the courts."

Those were the opening words of Illinois State Comptroller Leslie Munger, who went on to give a very matter-of-fact, albeit bleak picture of the state's fiscal status.

"When the State is doing little toward solving its budget problems, then the courts have to step in and order payments to certain groups," she said. "The problem is that sometimes, a judge may order payments without knowing whether or

not the state has the money to make them."

The big bad numbers

Munger dropped some pretty big numbers throughout her address:

- \$110 million goes in and out of the pension fund every day.
- Illinois has \$7 billion in unpaid bills.
- Illinois owes \$400 million just in fees and late charges.
- The courts have mandated payments for higher education, social services, drug and alcohol programs and respite care. Illinois is on the hook to pay back \$2 billion for those services.

"I realize it is hard to get your head around these numbers," she said.

Last month, Munger decided to treat paychecks to elected officials just the same as all of its financial obligations – get in line!

"Now everyone is in the line," she said. "Why should

officials be paid when those they serve are not?"

That comment brought a round of applause.

"We are barely keeping the doors open at places that serve our most vulnerable residents," she continued

Suggestions for a solution

Munger offered suggestions to get the state back on track and in control of its finances again.

"First, we need to start solving the problem, not just the symptom," she said. "We need to invest in getting people in this state back to work. We have so many assets here, transportation, farms, higher education institutions, there's no reason not to work together toward a solution."

Knowing the state must continually look for ways to make things faster, cheaper and better, Munger said she had reduced her staff by 20%, which saved \$1 million in the first two months.

"All departments of government need to follow that lead," she said.

Then she talked about economic growth, calling it "a total game changer."

"That is the area that will allow us to grow the tax base, which will bring in more investment and more growth," she said. "We need to put Illinois and our taxpayers first."

She offered to help as much as possible.

"Îr can't vote [in the legislature], but I have a megaphone," Munger said, indicating she would keep fighting the good fight and making sure her voice is heard.

The program included a Business Leaders Roundtable, moderated by independent journalist Lisa Leiter.

The panelists were: Sean Chou, CEO, Catalytic; Mike Vivoda, Sr. VP and president, West Region, Northwestern Memorial Healthcare; and, Ray Ziganto, president of the manufacturer Bi-Link.



Fees vary for residents vs. non-residents. Passes are available for the following fees:





Munger impressive at Regional Business Outlook luncheon

Advocates working together to solve state's financial woes

Illinois Governor Bruce Rauner was expected to speak at the 7th annual Regional Business Outlook luncheon on Tuesday, May 3, but had to decline and Illinois State Comptroller Leslie Munger delivered the keynote address instead. The luncheon was

presented by Choose DuPage, IceMiller Legal Counsel and Mesirow Financial.

Sponsored by BMO Harris, Ball, Blooming Color Printing, Maclyn and PNC, the program began with DuPage County Board Chairman Dan Cronin offering the DuPage County Business Outlook.

"We have done what we can


to keep business costs low," he said. "The property tax rate in the County has remained flat. In sales tax, the county has been collecting a one-quarter cent sales tax, which is ending, so we can put that money back in the taxpayer's pocket.'

A key theme of the luncheon was consolidation of governmental entities, an issue Cronin has been taking on ever since his days in the Illinois Senate. The most prominent example was combining the juvenile detention facilities of DuPage and Kane Counties into one to save costs on operations, personnel and other resources. Cronin has been one of the most vocal advocates for reducing the size of govern-

Cronin urges reducing units of government

'There are 8,480 units of local governments in Illinois and a dozen or so special taxes," Cronin said. "There are 'ghost governments' out there that fly under the radar and keep their allotment coming in from the state, while doing very little to






VILLA PARK — Willow-Maximillan brook senior Sarovich was recently named as a recipient of a Chick Evans Scholarship for Caddies.
