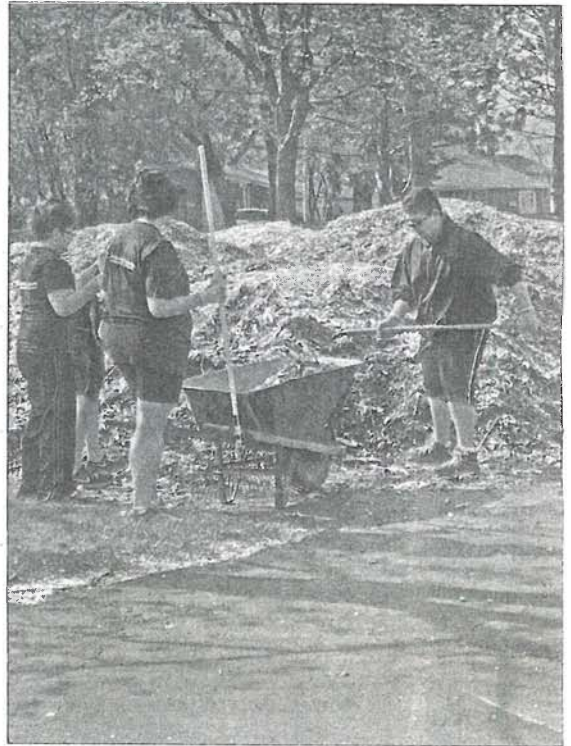

Warriors place third in WSC Gold frosh-soph meet

The Willowbrook boys track team recently competed in the Class 3A Wheaton-Warrenville South sectional.

The Warriors placed seventh in the 400 relay with a time of 44.25. Marco Martinez placed ninth in the 3,200 with a time of 10:04. Eddie Tribue was

10th in the 100 with a time of 11.64. Casey King took sixth in the 800 with a time of 1:59.14, while Chris Turek was ninth at 2:01.42.

Tribue was eighth in the 200 with a time of 23.42. The Willowbrook 1,600 relay finished 10th at 3:42.65. Noah Nagle was 11th in the triple jump at 39-11 1/2.

Earlier, the Warriors took sixth at the West Suburban Conference Gold Division meet hosted by Morton with 55 points.

Will Schuller took second in the 300 hurdles with a time of 43.53. King was sixth in the

800 with a time of 2:06.28. Lucas Olson was fifth in the shot put at 43-10, while Joe Knudson was sixth at 43-10 as well.

The Warriors were third in the 1,600 relay with a time of 3:32.10. Sam Trucano took second in the discus with a throw of 137-11.

The Warriors were fourth in the 400 relay with a time of 44.36. Schuller was fourth in the 110 hurdles with a time of 16.31.

Nagle placed sixth in the triple jump at 39-10. Martinez was fourth in the 3,200 with a time of 10:13.34. Nagle tied

for third in the high jump with a mark of 5-8. Josan Murphy was sixth in the 400 at 53.40.

Willowbrook took third in the frosh-soph conference meet with 92 points. Notable finishes included Pat Florey taking fourth in the long jump at 17-11. Gian Enriquez was fifth at 17-4 1/2.

CJ Harris placed third in the 100 at 12.16. Willowbrook won the 1,600 relay in 3:43.65.

Brandon Loth won the shot put with a mark of 40-10, while Christian Washington was second at 38-8. Enriquez was fourth in the triple jump at 35-8 1/2. Alex Medina was

fifth at 35-3 1/2.

Harris was fifth in the 200 at 25.44. Loth won the discus with a throw of 116-4 1/2. Matt Caron was fourth in the 1,600 with a time of 4:57.24. Willowbrook was third in the 800 relay with a time of 1:41.50.

William Stout was fifth in the 300 hurdles with a time of 49.18. Florey won the 400 with a time of 53.78. Casey Rosas was sixth with a time of 56.88.

Willowbrook was second in the 3,200 relay with a time of 9:14.67. Medina was sixth in the 800 at 2:14.77.

ADDISON — Gabriela Jurkiewicz has been named as Addison Trail's April recipient of 88's Best recognition for her academic accomplishments. Jurkiewicz, a senior, was recognized during the April 11 District 88 Board of Education meeting.

During her time at Addison Trail, Jurkiewicz has taken 13 honors courses and 11 Advanced Placement (AP) college-level courses.

"Jurkiewicz has been my student for two years in Spanish 4H and now in AP Spanish Literature, the most rigorous course offered in the World Language Department," said Erica Craig, World Language Department Chair. "As one of only two non-native students in AP Spanish Literature, she is excelling with high marks on her assessments and essays. She is intuitive and has a keen eye for detail, and her contributions to our class are always thought-provoking and astute. She is mature beyond her years, and her confident sense of self is inspiring for her peers. Jurkiewicz has been one of the brightest students I have had the privilege to

teach."

Career and Technical Education teacher Jeff Laschinski agreed.

"Jurkiewicz is the kind of student every teacher wants to have in class," he said. "She does great work and is motivated, but also is friendly, polite and is a person of high character."

While she excels in all subjects, English is her favorite.

"This is the first year I've had the pleasure of having Jurkiewicz in class, but it did not take long to notice how gifted she is," said Laura Jurik, AP English Literature teacher. "A stellar English student, she writes beautifully, with amazing clarity. Very few students read with her level of sensitivity and insight. She might not be the loudest voice in the room, but she contributes in the most valuable places, challenging ideas with tact and humility. Jurkiewicz possesses the much-needed qualities in a journalist — (aside from) the intelligence and talent, she has the character to provide an ethical and unbiased point of view."

English teacher Jessica Clark

encouraged Jurkiewicz to join the Torch, Addison Trail's newspaper; she did, and she hasn't looked back. Jurkiewicz loves journalism, particularly political stories, and loves how being a part of the Torch has helped with learning how to write as a journalist. It also has helped her break out of her comfort zone through the interviews she has to do and the people she meets.

All four years of her high school career, Jurkiewicz also has participated in Pay It Forward, Key Club and International Fest. She was a member of the bowling and cross-country teams for one year. This year, she has focused on Youth and Government, Model UN and DECA, where she recently participated in the DECA International Career Development Conference in a promotional campaign plan for Fashion Merchandising.

Jurkiewicz plans to attend University of Missouri and study journalism. She plans to be involved with the student newspaper and would like to try her hand at broadcasting. She also is considering earning a minor in law.

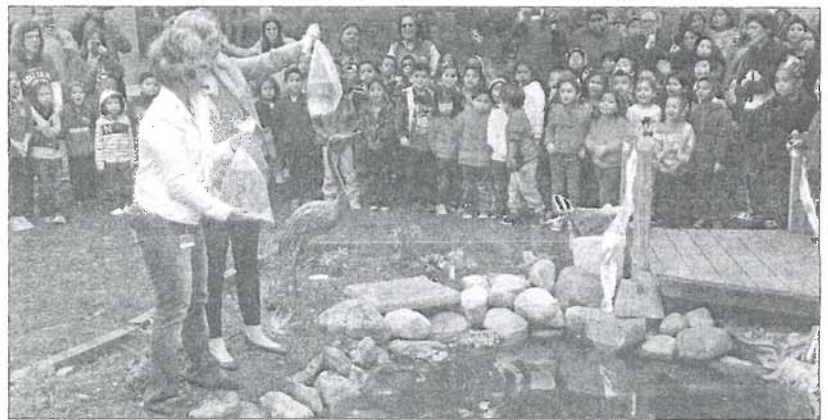

Addison Trail boys track team qualifies two for state meet

Conrad wins 200, Carr-Jones second in high hurdles

The Addison Trail boys track team finished eighth at the recent competitive Class 3A Wheaton-Warrenville South sectional.

The Blazers were one of eight teams in the field to score 30 or more team points.

Addison Trail qualified a pair of individuals for this weekend's Class 3A state finals meet in Charleston.

Junior Darrion Conrad won the 200 sectional title with a time of 22.27, while teammate

Jordyn Carr-Jones was second in the 110 high hurdles and earned a state berth. Carr-Jones finished in 14.97. A Glenbard North runner won the sectional title at 14.75.

Conrad also was third in the 100 with a time of 11.16. Sophomore Marco Flores was fourth in the 800 with a time of 1:58.52.

The Blazers were third in the 800 relay with a time of 1:30.06. Carr-Jones was seventh in the 300 hurdles with a time of 42.54. Chris Purdy placed eighth in the long jump at 21-10.

In earlier action, the Blazers competed in the West Suburban Conference Gold Division meet. Addison Trail took third in the conference.

Carr-Jones won conference

titles in the 110 high hurdles and 300 hurdles, while Conrad won the conference title in the 200.

Additional Addison Trail all-conference athletes included Ryan Baig (400 dash and 1,600 relay), Jonathon Cabrera (1,600 relay), Conrad (800 relay), Carr-Jones (1,600 relay and 800 relay), Stefano Favuzzi (800 relay), Marco Flores (1,600 relay), Alfredo Gonzalez (300 hurdles), Chris Griffith (800 relay), Purdy (long jump, 800 relay) and Michael Renc (discus).

Carr-Jones won the 300 hurdles in a time of 42.79. Gonzalez was fifth at 44.87. Addison Trail was fourth in the 3,200 relay at 8:45.91.

Addison Trail was second in the 1,600 relay at 3:29.55.

Renc was fifth in the discus at 122-3. He's only a sophomore.

Carr-Jones won the 110 hurdles with a time of 14.81. Purdy was second in the long jump at 22-5. Conrad was third in the 100 at 11.12. Demetrio Cervantes placed sixth in the 3,200 with a time of 10:58.99. Purdy tied for fifth in the high jump at 5-8. Addison Trail was second in the 800 relay at 1:32.42. Baig was third in the 400 at 51.94.

Conrad won the 200 title with a time of 22.58.

Addison Trail was fourth at the frosh-soph level with 89 points.

Notable frosh-soph finishes included Alvaro Garza placing fourth in the 100 at 12.20. Kevin Marroquin was fifth at 12.24.

Addison Trail was second in the 1,600 relay at 3:44.47. Randall Petrbock was third in the shot put with a throw of 38-3.

Ryan Sheehen was second in the discus with a throw of 108-7. Albert White was third in the high jump with a mark of 5-4. Daniel Bueno was fourth in the 3,200 with a time of 11:01.75. David Reyes was fifth at 11:09.46.

Austin Rohlf was third in the 300 hurdles with a time of 47.71.

Alvaro Garza was second in the 400 with a time of 53.96. James Carr won the 110 high hurdles in 18.36 and Rohlf was fifth at 19.82.

Baig, Favuzzi and Anthony Menolascino earned West Suburban Conference Gold Division all-academic honors.

Willowbrook boys volleyball teams wins two matches at invitational

The Willowbrook boys volleyball team headed into this week's Downers Grove South regional with a 14-win regular-season effort.

The Warriors finished West Suburban Conference Gold Division action with a 3-3 record and took third place.

In recent action, Willowbrook went 2-1 in pool play at its own Warrior invitational. The Warriors scored wins against Wheaton North and Glenbard East.

Also, Willowbrook lost 25-17, 19-25, 25-14 to Hinsdale Central in a WSC crossover match and dropped a 25-20, 25-21 WSC Gold match to District 88 neighbor Addison Trail.

Willowbrook has been playing without Ian Walsh, who sustained an ankle injury against Glenbard East in the Warrior invitational and did not play the remainder of the tournament or in the matches against Hinsdale Central and Addison Trail. Willowbrook coach Ryan Bazon said Walsh was due to return earlier this week for the playoffs.

The 6-6 Walsh, who will play at Loras College next season, had 109 kills and was hitting .378 through late

last week. He also had a team-best 91 blocks.

"With Ian we were starting to put a lot of pressure on other teams at the net," said Bazon. "Our blocking game was improving, which greatly helped our defense and led to better attacking opportunities."

Bazon said one recent change that helped the squad was moving setter Lucas Betts, a senior, to outside hitter. "This has helped our hitting efficiency and middle-back defense," Bazon noted. "Moving Lucas to outside hitter allowed us to pull up sophomore Nick Cookingham to set for the varsity team. He adds good consistency to our offense and gives us some good young talent moving forward with the program."

Statistically, Ivan Tassev was leading the team in kills with 151. Brendan Waldorf had 110 kills. Tassev also was tops on the team with 29 aces. Andy Shreckengost was the team leader in blocks with 80. Calvin Linnig had 258 assists, while Cookingham had 178. Jack Maksymac was tops on the team through late last week in digs with 181.

The Warriors opened regional play earlier this week against Metea Valley.

The Fenton softball team went 3-1 during a recent-four game stretch.

The Bison swept a non-conference doubleheader from Amundsen by scored of 16-0 and 11-0.

In the second game, Fenton's Jocelyn Souvannasy threw her second career no-hitter. Junior Taylor Spizzirri went the distance to earn the win in the

opener.

Fenton also dropped a 14-0 Metro Suburban Conference West Division game to Glenbard South, but bounced back to score a 7-5 MSC West win over Wheaton Academy.

Against Wheaton Academy, Fenton trailed 5-1 in the bottom of the fifth, but scored two runs in that frame and then four more runs in the sixth inning. Spizzirri was the winning pitcher.

The doubleheader against Amundsen also was Fenton's senior night. "It was a special night as we honored six seniors who have provided us with 22 seasons of varsity softball," said Fenton coach Dave Mello.

Souvannasy (University of Missouri), Ellie Gonzales (Ohio State), Clarissa Guevara (Tennessee), Alex Stoklosa (College of DuPage), Courtney Susmarski (Western Illinois) and Diana Pikul (Arizona State) all were honored.

"Those six seniors will be greatly missed," said Mello. "They have given so much to our program."

Through 29 games, Pikul was leading the team with a .407 batting average and also was tops in on-base percentage at .492. Jenna Geraci was leading the team in hits with 28 and RBI with 25. Ellie Wassmann was the team leader in runs scored with 26 and stolen bases

with 30.

Spizzirri had four pitching wins and 30 strikeouts, while Susmarski was tops in fielding with a .973 fielding percentage.

"Taylor has really been on quite a roll lately," said Mello.

Mello noted Spizzirri was particularly impressive in a tough-luck loss to IC Catholic Prep where she went seven innings and threw 51 of 67 pitches for strikes.

"It was one of the most efficient pitching performances we have had in the last decade," said Mello.

Isa Lozada and Gonzales also have been key cogs of late for the Bison. "We made the switch putting Isa (a fresh-

man) at shortstop and moving Ellie back to second where she played as a freshman and sophomore. Both have really been working great together and have really helped solidify our infield defense. Ellie has been a great mentor for Isa. Both have really stepped up lately."

Fenton opened postseason play earlier this week at home against Proviso East. If Fenton won that game it was scheduled to play Niles West on Tuesday. This is Fenton's first year in Class 4A classification in softball.

"We are really playing much better of late," said Mello.

Addison Trail's Kroll logs two top 10 state track finishes

Willowbrook baseball team defeats Downers Grove South

Addison Trail junior Lauren Kroll capped off her track and field season in fine fashion.

Kroll earned a pair of top 10 finishes in the 100 and 200 at the recent Class 3A girls track and field state finals at Eastern Illinois University.

Kroll finished seventh in the state in the 200 with a time of 24.99. Kroll qualified for the state finals by taking second in her preliminary heat with a time of 25.41.

Kroll also took ninth in the state in the 100 dash with a time of 12.43. Kroll made the finals after running 12.51 and finishing third in her preliminary heat.

Kroll is only the second girls track athlete in school history to finish in the top nine at state in two events in the same year. Sharon Rodenhauser did it twice in the early 1980s in the shot put and discus.

TJ Geritano went 2-for-4 with a double. Kyle Ferguson was 2-for-3 with a double and two runs scored. Trevor Jalosynski

had a hit and an RBI, while Mark Molitor had a hit and an RBI.

Willowbrook then recorded a 6-2 WSC crossover win against Glenbard West. Willowbrook had nine hits in the game.

Geritano walked twice and had an RBI. Ferguson had a hit and two RBI. Kyle Martyniuk had two hits (including a double) and two RBI. MJ Ranieri had a hit and an RBI. Cam Zunkel had two hits (including a double), as did Danny Olson. Willowbrook also stole five bases.

Alec Michaelson was the winning pitcher. He went six innings and allowed no runs on three hits, while striking out five. Ronne Reitz earned the save.

In a 14-0 five-inning win over Proviso West, Willowbrook scored five runs in the first inning and seven more in the third inning.

Ferguson was 1-for-2 with three runs scored and three RBI. Olson had two hits. Pizur had two RBI. Garbacz and Reitz each had a hit and two RBI. Ben Espinoza had two stolen bases.

Reitz pitched a five-inning complete game to earn the win. He allowed three hits and struck out five.

In a 12-2 non-conference win against Glenbrook South on family day at Willowbrook, the Warriors scored six runs in the sixth inning and had 11 total hits.

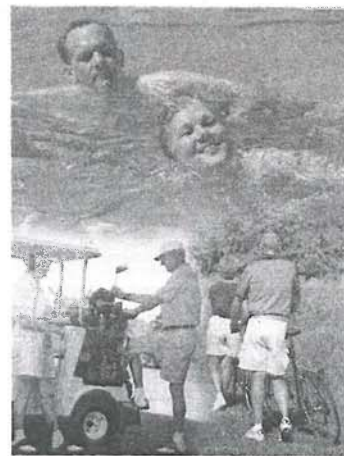

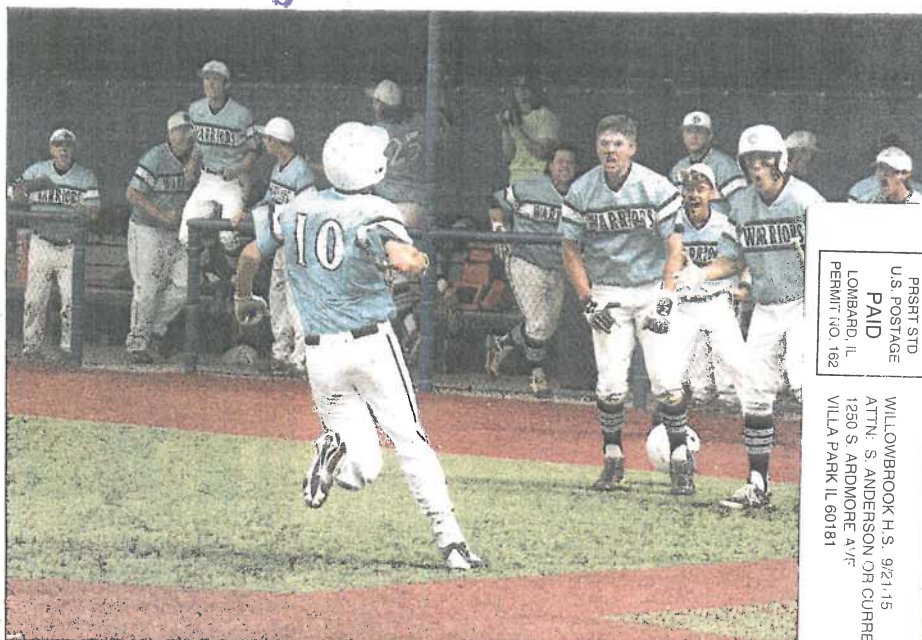

Village marks Memorial Day at renovated Cortesi Park

Hundreds of people attended Monday's Memorial Day service at Villa Park's newly renovated Cortesi Veterans Memorial Park. In addition to honoring the men and women of the United States military who died while serving their country, the service celebrated the improvements to the park. The upgrades include a new memorial at the south end of the park, which is located at Cortesi and Kenilworth avenues, just west of Villa Avenue and just south of the Great Western Trail.

Monday's ceremony began with the dedication of the renovated park, which features a memorial with six flags representing branches of the U.S. military—the Army, Navy, Marine Corps, Air Force, Coast Guard and Merchant Marine. Those six flags encircle an American flag that's located in the center of the memorial.

The attendees of the ceremony included the children of the park's namesake—longtime Villa Park resident Dr. L.R. Cortesi—who passed away in 1983. Dr. Cortesi, who was born in 1913, joined the U.S. Army in October 1941. During World War II, he served as a surgeon. He was in charge of a medical team on a hospital ship off the coast of Normandy at the time of the D-Day invasion in June 1944. Cortesi, who was a major in the army, later directed a medical train while serving in Europe. He was involved in the Battle of the Bulge near the end of the war in Europe in late 1944 and early 1945.

According to a plaque in the renovated park bearing his name, Cortesi was discharged from the military in 1945, having never taken a day of leave.

Cortesi and his wife Genevieve were

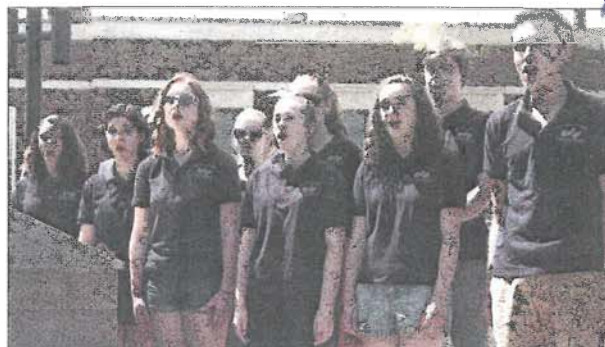

Rams win two shootouts to claim sectional title

The Glenbard East girls soccer team continued its post-season push by winning the championship at the IHSA Class 3A Hinsdale Central Sectional. The Rams won a pair of penalty-kick shootouts at the sectional, beating Lyons Township Thursday and edging Hinsdale Central on Saturday. The victory over the Red Devils left the Rams as one of eight teams remaining in the Class 3A tournament. Glenbard East faced Naperville North in last night's IHSA super-sectional match at Lewis University in Romeoville. The winner will advance to the state semifinals, which begin this Friday at North Central College in Naperville.

"We played with some swagger,"

said Glenbard East coach Kent Overbey after Saturday's win. "The bottom line is we are one of eight teams left in [Class] 3A. No one expected us to get this far."

Both of the Rams' sectional matches were scoreless ties at the end of regulation—two 40-minute halves—and a pair of 10-minute overtime periods. Deadlocked at 0-0 after 100 minutes of each match, the Rams prevailed in penalty-kick shootouts. They beat Lyons Township 4-3 in Thursday's shootout, which featured five attempts per team. Saturday's shootout, which featured seven shots per team, also ended 4-3 in favor of the Rams.

Both sectional wins were

officially recorded as 1-0 victories by Glenbard East, which will enter the super-sectional with an overall record of 22-4. The Rams have held their opponents scoreless in 19 of the team's 22 wins.

Glenbard East won the first IHSA girls soccer regional title in school history on May 20, when it defeated Downers Grove North 2-0 in Lombard. The Rams opened the playoffs with a 5-0 win over Leyden on May 16.

Lyons Township was the sectional's No. 1 seeded team. Glenbard East is the No. 5 seed. The Rams and Lyons played the first half of their match on Wednesday in Hinsdale. The match was delayed about two hours by thunderstorms. The teams managed to play the first

half before more storms arrived, postponing the finish until Thursday.

Glenbard East has met Lyons Township in several regular-season matches in recent years. The Rams had never beaten the Lions until this season, when they prevailed 1-0 in a May 12 contest in Lombard. Two weeks later, the teams squared off in their post-season battle.

The Rams' penalty-kick lineup in the shootout against Lyons Township included senior Brittany Paganucci, junior Dana Plotke, senior Sammie Sarles, sophomore Katie Hansen and senior Holly Ward. Paganucci, Plotke and Hansen converted their attempts. The shootout was even at 3-3 through four rounds. The Lions missed their fifth kick against Glenbard East senior goalkeeper Sierra Dana,

leaving the door open for Ward to close out the match with a successful kick. Ward converted her attempt to end the match.

Another 100 minutes of scoreless soccer on Saturday forced the shootout between the Rams and Red Devils. The shootout was tied at 2-2 after each team had attempted five kicks. Plotke and Hansen delivered Glenbard East's successful kicks. The shootout, now in sudden death, continued, with Sarles converting the Rams' sixth penalty kick. The match ended when the Red Devils failed to score on their ensuing attempt.

Massive rally lifts Warriors; they then lose in a regional final

The Willowbrook baseball team opened the IHSA Class 4A playoffs with a monumental comeback against St. Francis in Friday's regional semifinal game at Lee Pfund Stadium in Carol Stream. The two teams were scoreless in the middle of the sixth inning, but the Spartans scored seven runs in the bottom of the sixth inning to take what appeared to be a comfortable 7-0 lead. Three outs from defeat, the Warriors scored seven runs of their own in the top of the seventh to tie the game. Willowbrook piled on eight more runs in the top of the ninth inning on its way to a 15-8 victory.

The Warriors' season ended less than 24 hours later following another extra-inning game—a 4-3 nine-inning loss to Lake Park in Saturday's regional championship game at the Lancers' home field in Roselle. Willowbrook completed the season with an 18-17 record.

Senior Cam Zunkel pitched five shutout innings on Friday before running into trouble in the sixth inning. Zunkel gave up five runs, only two of which were earned runs, during the inning. Alec Michaelson relieved Zunkel and allowed two more runs in the inning.

The Warriors' seventh-inning rally included a two-run double by Zunkel

that cut the Spartans' lead to 7-3 with one out. Mark Molitor added a sharp single that brought in two more runs to cut the Spartans' lead to 7-5. 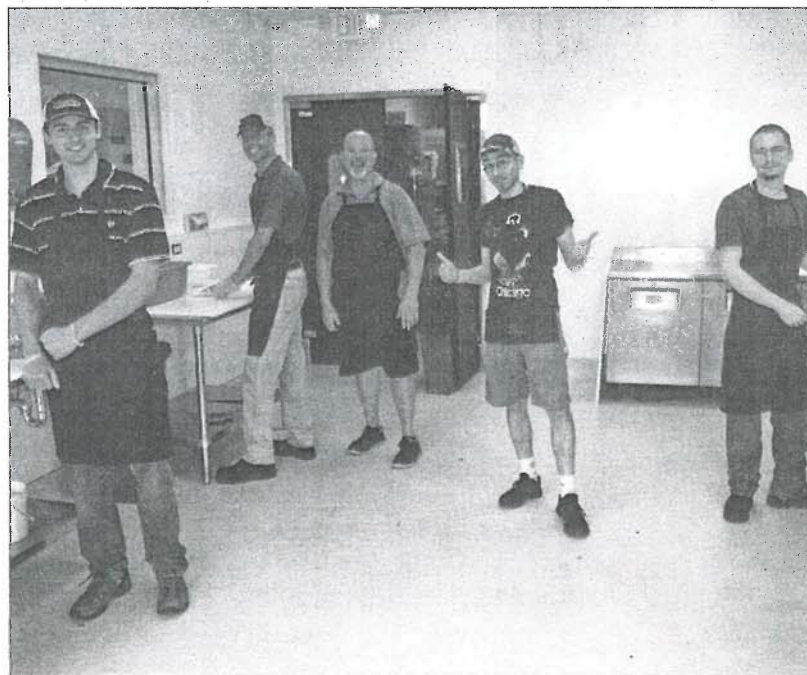

McEllin is with Troop 242. He joined Cub Scouts when he was in first grade and transitioned to Boy Scouts when he was in fifth grade.

"I have always had a love for the outdoors, so it only seemed

natural for my parents to enroll me in my local Cub Scout pack in 2004," McEllin said. "After the switch from Cub Scout to Boy Scout, what made me stick around was the amount of activities one can do in scouting and the prospect of actually doing them."

For his Eagle Scout project, McEllin removed overgrown bushes near St. Paul Lutheran Church in Villa Park and cleared debris from underneath the bushes. He then planted 34 new, smaller bushes, as well as some wild grasses. McEllin said he had to plan out his project and get it approved by a Council representative. He then had to fundraise to buy the new plants, and he raised more than

\$300. He said the project took nearly 130 hours of manpower to complete (not including the planning process).

McEllin said he will continue with the Boy Scouts program by serving as Assistant Scoutmaster with Troop 242.

"(Assuming that role) will not only allow me to continue being a part of my troop, but it also will give me a larger capacity of giving back to my troop in the form of teaching future and current scouts about different scouting-related subjects," McEllin said.

McEllin will begin his college education at Illinois State University this fall, where he plans to major in social studies education.

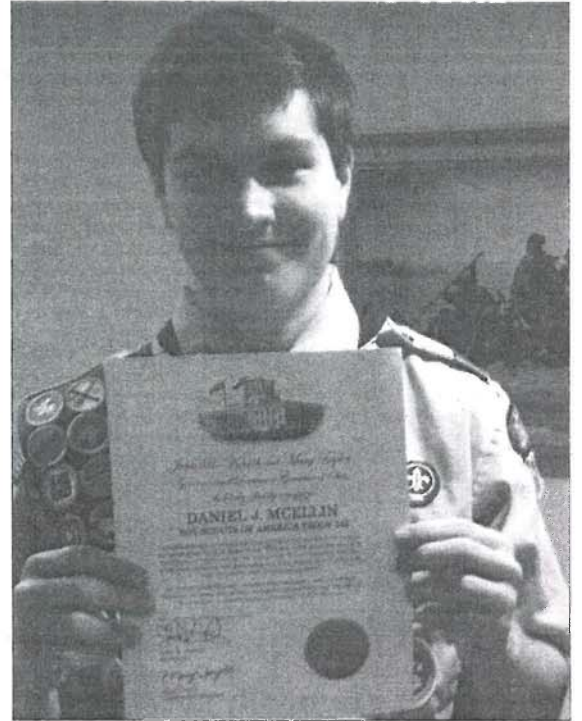

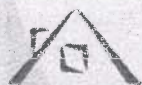

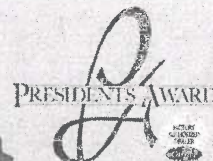

Taking center stage

Addison Trail's Conrad thrilled for state meet opportunity

Addison Trail junior Darrion Conrad would likely be a frontrunner for a brother of the year medal if one such award existed.

Conrad explained he stepped aside at last year's sectional meet in order to give his older brother, Darius (who now plays football at Youngstown State), a better chance at qualifying for state in the 200.

"I wanted to give Darius a chance to make it," he said. "If I didn't run I knew it would bump him up in the 200. If I would have been there, it could have dropped him a spot. It was tough. I knew I could probably make it down in the 200, but I also knew I had two more years left to go and Darius was a senior. I wanted to help him."

This year, Conrad helped himself, earning a berth in the Class 3A state track and field meet in Charleston. Conrad finished fifth in his preliminary heat at Eastern Illinois University with a time of 22.79.

"I worked on the blocks more

than I ever have," said Conrad earlier last week regarding his improvement in the 200. "I'm also more conditioned. I finish the races with a lot more energy."

Conrad attributes part of his better conditioning to his eating habits. "I have been eating healthier," he said. "At the start of February I didn't lift as much because when you lift, you put on weight. I've been lifting lighter and eating right. I used to eat five meals a day and now I'm eating three. I'm not eating heavy meals. I'm eating lighter, especially at lunch. I don't want to be too full before track so I can get in the best workout I can."

Conrad said, for him, running a successful 200 boils down to his performance on the race's curve.

"For me, it's the curve," he said. "Where it starts I want to beat everybody off the curve. If I do that I feel like I can get at least third place—no worse than third. I think during the season I only came in third once."

Conrad enjoys multiple parts

of the 200. "I like it because I can think during the race," he said. "I'm good at the 100, but I'm better at the 200 because I can think more. The 100 is quick. It's like 10 seconds. The 200 is quick, but I like it more because it doesn't seem as fast. I've come to really enjoy the 200."

Conrad said he received some advice from his older brother about the state meet. Darius Conrad qualified in the high jump while at Addison Trail.

Conrad also plays wide receiver on the Addison Trail football team. He would like to pursue both sports at the next level.

"I think I do both pretty well," he said. "I would like to do both in college. I feel I could make contributions in both sports at a high level."

"Darius told me how awesome the state meet is," he said earlier last week. "I still can't believe I qualified for state. I've been waiting two years to make it."

And thanks to his hard work, the wait is over.
