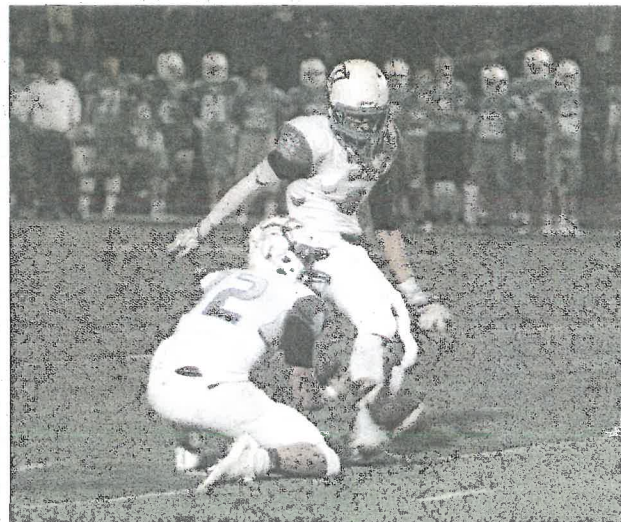

New business donates four monitors to fire department

The Villa Park Fire Department will receive four television monitors from a newly opened business in the village.

Firehouse Subs, located at 298 W. North Ave., Unit 2, will donate the monitors—two 39-inch screens and two 32-inch screens. Two monitors will be installed in each of the village's two fire stations. Station No. 81 is located at 1440 S. Ardmore Ave. Station No. 82 is at 102 W. Plymouth Street.

Villa Park Fire Chief Ron Rakosnik and Yogi Patel, the franchisee of the village's new Firehouse Subs location, discussed the donation at a recent Villa Park Village Board meeting. The new business opened on Aug. 31.

Patel explained that when a new Firehouse opens in a community, the business contacts the local fire department to ask for donations of items to be displayed in the restaurant. In turn, the business offers assistance to the fire department.

The items the Villa Park Fire Department donated to the new Firehouse Subs location include a helmet, a wooden pike pole, a high-expansion foam nozzle, a firefighter's jacket, an air pack and a Stokes basket—a wire stretcher used to transport patients. All of the items are on display inside the restaurant.

The soon-to-be-installed monitors will serve the department's Zetron radio dispatch system. According to Rakosnik, the monitors will display numerous pieces of information. When a call comes in, for example, the monitors will provide a map detailing the best route to reach the location of the call. The monitors will also provide weather details and the department's manning schedule. The larger monitors will be installed in the stations' apparatus rooms. The smaller monitors will be located in the living areas of each station.

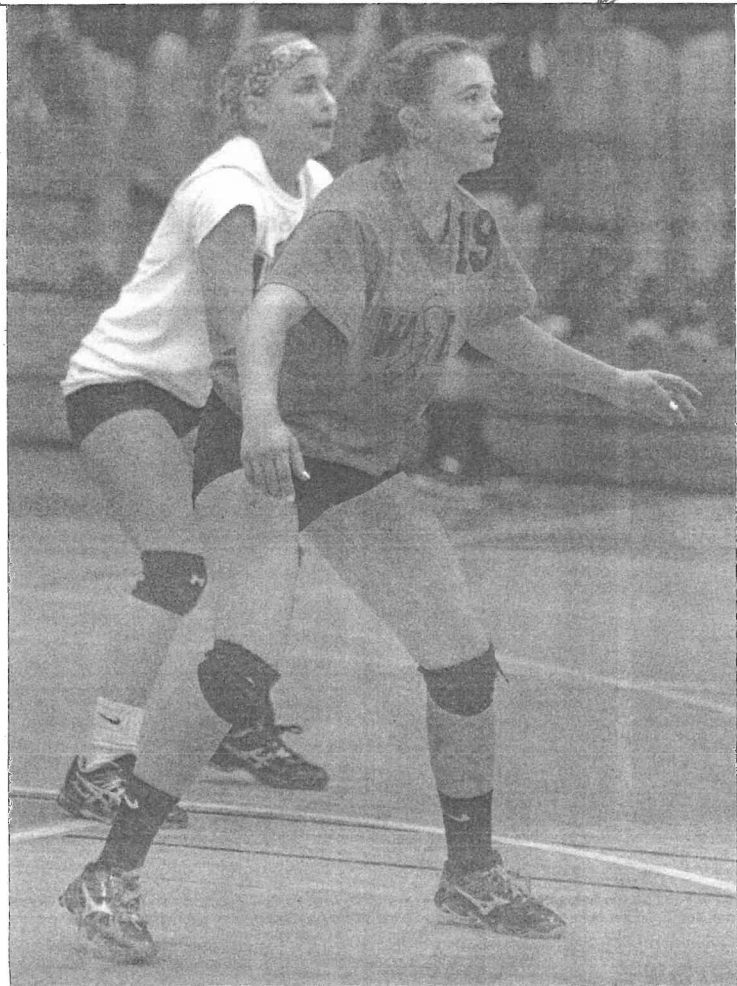
Rakosnik said the department applied unsuccessfully for a grant from another Firehouse Subs in the village a few years ago to obtain the monitors. In addition to receiving the monitors from the new business, the department learned of a separate grant from Firehouse Subs. In celebration of the opening of 1,000 locations nationwide, the company is donating 1,000 automated external defibrillator (AED) units. The Village of Villa Park will receive two of those units. Rakosnik said the units will be placed in the police department and in the village hall.

Patel said the AED units are provided by Firehouse Subs' public safety foundation fund. That fund raises money by asking guests to round up to the nearest dollar for the price of their meals.

Village board approves ordinance proposing establishment of special service area at North Avenue Townhomes

The Villa Park Village Board approved an ordinance at its Sept. 12 meeting to propose the establishment of a special service area at the North Area Townhomes. The townhomes consist of 18 buildings on the south side of North Avenue, near Villa Park's western border with Lombard. Each of the 18 buildings contains six units.

The establishment of a special service area at the townhomes would enable the Village of Villa Park to provide additional services to the area. The property owners at the complex would receive a special assessment for those services.

Previous village board meetings have included discussion about criminal activity and garbage-related problems at the townhomes.

The proposed special services area calls for a tax rate not to exceed \$3 for every \$100 of equalized assessed value.

The special services to be provided in the area would include: reconstruction of driveways and parking spaces, garbage service, construction of new perimeter fencing, drainage and landscape improvements, community policing services and administrative and legal costs.

There will be a public hearing about the proposal at Villa Park Village Hall at 6 p.m. Monday, Oct. 10. The hearing will reportedly include

the consideration of the issuance of up to \$1.6 million in special service area bonds. The bonds would be retired over a period of up to 20 years with funds generated by the special service assessment.

Preventing the establishment of a special service area would require a petition signed by at least 51 percent of the registered voters who live at the townhomes, as well as at least 51 percent of the property owners at the site. That petition would have to be filed within 60 days of the Oct. 10 public hearing.

Anita Lepianka, whose family owns five buildings—a total of 30 units—at the complex, spoke at the Sept. 12 meeting. Lepianka opposed the establishment of the special services area. She asked village board members why she should have to pay for the maintenance of other people's property.

Lepianka said it wouldn't be possible to obtain signatures from at least 51 percent of the residents and 51 percent of the property owners to block the establishment of the special services area.

She stated days after the meeting that despite owning 30 units, her family would receive just one vote toward the proposal. Lepianka told board members at the Sept. 12 meeting her only recourse in opposing the proposal would be to pursue litigation.

Willowbrook High School student dies following medical incident

A Willowbrook High School student died Sept. 19 after a medical incident at the Villa Park school.

Abdul Jalal, a 15-year-old second-year special-education student from Lombard, died after being transported to Elmhurst Memorial Hospital. District 88 provided few details about Jalal's death.

According to the district, Jalal suffered a medical emergency during the school day.

The Villa Park police and fire departments declined to provide information about the incident.

The police department referred inquiries to the DuPage County Coroner's Office. The coroner's office issued a news release on Monday. According to the release, the Villa Park police and fire departments were summoned to the school at 12:16 p.m. for a student who was apparently choking in the cafeteria. Jalal was reportedly unresponsive as paramedics began life-saving protocol measures.

Villa Park paramedics transported Jalal to the hospital. He reportedly died at 1:09 p.m.

The release from the coroner's office stated an autopsy was performed on Sept. 20. The autopsy provided a preliminary indication that Jalal may have choked on a piece of food.

The coroner's news release stated Jalal had Down Syndrome. The syndrome did not appear to have any bearing on Jalal's death, according to the release.

"Our hearts go out to the family members and friends of Willowbrook student Abdul Jalal," stated Willowbrook Principal Dan Krause in his weekly column in the District 88 newsletter.

"It is always difficult to lose a member of our Willowbrook family, and we will continue to help each other through this difficult time. Abdul was a true Willowbrook Warrior in every sense of the word and made an impact throughout Willowbrook High School. Abdul always brought a smile to those around him, and his contagious enthusiasm will forever be part of our school."

According to the District 88 newsletter, Jalal was a fan of superheroes. Willowbrook students and staff wore superhero T-shirts in his honor on Friday.

Tonight's town hall meeting focuses on upcoming referendum

The Village of Villa Park invites residents to attend tonight's town hall meeting at the Iowa Community Center, located at 338 N. Iowa Ave. The meeting, which will begin at 6:30 p.m., will include information from village staff about the referendum question on the ballot in the Nov. 8 election.

The question will ask Villa Park voters if they want to approve a half-percent increase in the village's sales tax rate, from 7.5 to 8 percent. If approved, the increase will reportedly generate about \$1.5 million annually. That money would be used to pay for village infrastructure projects, including the installation of storm sewers and water mains.

The question, as it will appear on the Nov. 8 ballot, states:

"Shall the Village of Villa Park increase the Village's Non-Home Rule Municipal Retailers' Occupation Tax and Non-Home Rule Municipal Service Occupation Tax (commonly referred to as a "municipal sales tax") from one half of one percent (.5%) to one percent (1.0%) for expenditure on public infrastructure in accordance with and subject to the provisions of Sections 8-11-1.3 and 8-11-1.4 of the Illinois Municipal Code (65 ILCS 5/8-11-1.3 and 65 ILCS 5/8-11-1.4)?"

The village's current sales tax rate of 7.5 percent includes the one half of

one percent municipal sales tax mentioned in the referendum question. That tax generates about \$1.5 million each year. The money is directed to the village's street improvement fund and used to pay for road repairs. Approval of the referendum on Nov. 8 would generate approximately \$1.5 million in additional funding.

Villa Park voters approved a referendum proposal in the election of November 2014 to authorize the village to borrow up to \$23 million to pay for road improvements. The funding related to that referendum can only be used for road work; it cannot be directed toward related underground projects.

The Villa Park Village Board approved a resolution at its Aug. 8 meeting to place the referendum question on the ballot in the Nov. 8 election. Villa Park Village Manager Rich Keehner stated at the Aug. 8 board meeting that, if approved, the tax increase would take effect July 1, 2017. Keehner also said that some of Villa Park's planned road projects are uncertain because the road-related work is funded, but the related underground work is unfunded.

Village staff will hold another town hall meeting to provide information about the referendum question on Thursday, Oct. 13. That meeting will also begin at 6:30 p.m. at the Iowa Community Center.

Fire Department holds open house on Oct. 15

The Villa Park Fire Department invites residents to attend its annual open house on Saturday, Oct. 15. The open house will take place from noon to 3 p.m. at Fire Station No. 81, located at 1440 S. Ardmore Ave. Parking will be available at the U.S. Post Office across the street from the station.

The open house gives children and adults a chance to visit the station and take an up-close look at some of the fire department's vehicles and equipment. Children will be able to use a real fire hose, wear

kid-sized firefighting gear and meet Sparky the Fire Dog. The open house will include fire safety puppet shows, as well as live fire demonstration. The fire demonstration will begin at 2:30 p.m.

The open house takes place during Fire Prevention Week, which dates back to the 1920s. The week is recognized in early October to commemorate the Great Chicago Fire, which began on Oct. 8, 1871.

Warriors rebound from a tough loss to shut out York

The Willowbrook football team bounced back from a disappointing homecoming loss to spoil another team's homecoming game.

One week after losing a 30-27 decision to Hinsdale South in Villa Park, the Warriors traveled to Elmhurst and shut out York 17-0 in a non-conference contest.

Willowbrook improved its overall record to 3-2, while York fell to 1-4. Friday's win gave the Warriors their second shutout of the season. Willowbrook beat Proviso West 35-0 on Sept. 2 in Villa Park to improve to 1-1. One week later, the Warriors opened the West Suburban Gold Conference season with a decisive 38-7 win at Addison Trail. Willowbrook dropped to 2-2 overall with the 30-27 homecoming loss to Hinsdale South on Sept. 16.

The Warriors' coaching staff expressed its disappointment to the team's players immediately after the loss to the Hornets. The coaches and players were naturally more upbeat after the road victory at York.

"It was a long week," said Willowbrook coach Nick Hildreth of the practices leading up to Friday's game against the Dukes. "Our focus was holding guys accountable. We

focused on minimizing mistakes and doing our job. We feel like we beat ourselves in our previous two losses [the loss to Hinsdale South and a 27-12 season-opening loss at Grayslake North on Aug. 26]. We wanted to clean those things up."

The Warriors didn't play a perfect game against the Dukes, but they managed to recover from each miscue. Moments after gaining possession on an interception by senior Khalif Copeland, Willowbrook coughed up a fumble early in the second quarter; York recovered the loose ball near the Warriors' 35-yard line. Willowbrook shut down the York offense on the ensuing series, forcing a punt.

Another Willowbrook miscue—a fumble of a York punt in the third quarter—gave the Dukes possession of the ball at midfield. Once again, the Warriors prevented York from mounting a scoring drive.

"It's hard to hold any high school team scoreless," said Hildreth. "They [the Dukes] are not a bad football team by any means."

The Warriors drove 72 yards for their first touchdown of the night. Senior quarterback M.J. Ranieri completed a 24-yard pass to senior Jonathan Kelso on a third-and-10 play from York's 36-yard line. Junior Jack Jensen delivered a 12-yard

touchdown run on the next play. Senior Mike Dembowski added the extra-point kick to give the Warriors a 7-0 lead with 2:40 left in the opening quarter.

Willowbrook senior William Schuller recovered a York fumble in the second quarter. Ranieri completed a long pass to Dembowski later in the period. The long gain led to Dembowski's 35-yard field goal kick, which extended the Warriors' lead to 10-0.

Copeland blocked a 41-yard field goal attempt by York on the final

play of the first half.

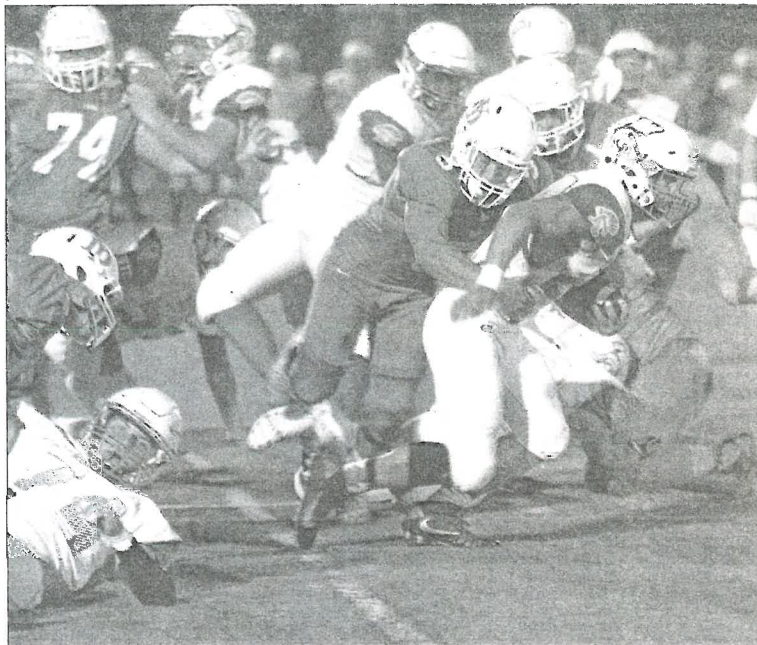
The Warriors locked up their victory when Ranieri completed a 6-yard touchdown pass to Kelso on a fourth-and-two play with about five minutes left in the game.

"We talked about how you define a team by what they do after they lose," said Kelso of the Warriors' recovery from the Sept. 16 loss to Hinsdale South. Kelso, who plays offense and defense, intercepted a York pass during the second quarter.

"Last week wasn't our best week," said Copeland. "Coming into this

game, we were focused. Everyone was clicking. We just made it easy on ourselves."

The Warriors' season continues with this Friday's conference home game against Morton (1-4 overall, 1-1 in the conference). Willowbrook needs to win three of its final four regular-season games to secure a berth in the IHSA playoffs. The Warriors will finish the regular season with conference games at Proviso East (Oct. 8) and Downers Grove South (Oct. 14), followed by an Oct. 21 home game against Leyden.

Rams endure a rough homecoming game against St. Charles North

The Glenbard East football team slipped to 0-5 following Friday's 46-2 loss to St. Charles North in Lombard.

The North Stars, who improved to 4-1, built a 32-2 halftime lead against the Rams. Glenbard East scored the only points of its homecoming game when St. Charles North snapped the ball out of the end zone during the first quarter. The North Stars held a 7-2 lead at the end of the opening quarter.

They outscored the Rams 25-0 during the second period.

Senior Scott Szabo gained a

team-leading 54 rushing yards on nine carries. Sophomore quarterback Bret Bushka completed eight of 22 passing attempts for 122 yards. He threw one interception. Junior Keonta Nixon made three receptions for 67 yards.

Senior Brandon Raines intercepted a St. Charles North pass.

The Rams will try to earn their first win of the season this Saturday, when they will play an Upstate Eight Valley Conference game against East Aurora (1-4 overall).

Willowbrook golfer makes a hole-in-one

Sophomore Joey Guthrie of the Willowbrook boys golf team sank a hole-in-one during Thursday's Addison Trail "Ryder Cup" Quad event at the Highland Course at the Indian Lakes Resort in Bloomingdale.

Using an 8-iron, Guthrie recorded the ace on the 135-yard, par-3 fourth hole.

"I knew it was a good shot, but I didn't think it would go in," said Guthrie, who was able to see the ball roll in the hole from the tee box. His slight fade landed a few feet left of the cup. The ball landed with some sidespin and tracked into the hole.

"I was in shock," said Guthrie of his reaction to the hole-in-one. I just dropped my club and starting jumping up and down."

The Warriors competed against Addison Trail, Morton and Glenbard North in the four-team event, which featured tandems of partners. The Willowbrook duo of Guthrie and junior John Morser recorded a 9-hole score of 45 on the par-36 course. Sophomore Jackson Hathaway and freshman Logan Rattana teamed up to fire a score of 42 for the Warriors, while juniors Tim Keefe and Buddy Martens turned in a score of 48.

The Addison Trail coach acknowledged Guthrie's hole in one during his announcement at the end of the meet. Guthrie gladly received handshakes from several of his fellow competitors.

The two-player teams from each competing school played a best-ball format for the first three holes. They played an alternate-shot format for the middle holes; the final three holes were played in a scramble format. Willowbrook placed fourth in the team competition with its overall score of 135. Addison Trail won the event championship with a score of 120. Glenbard North (127) placed second, while Morton (132) claimed

third place.

Willowbrook lost a West Suburban Gold Conference dual meet to Downers Grove South on Sept. 20 at Sugar Creek Golf Course in Villa Park. The visiting Mustangs defeated the Warriors 143-181 in the dual meet. Keefe shot the low round for Willowbrook, firing a 9-hole score of 43 on the par-32 course. Martens shot a 44, while Guthrie and junior Max Venchus contributed scores of 46 and 48, respectively.

The Warriors won a conference meet against Morton on Sept. 15, beating the Mustangs 169-186 at Sugar Creek. Martens shot Willowbrook's best score, carding a 4-over-par total of 36. Keefe added a 42, while junior Jake Hoppensteadt and Venchus tallied scores of 45 and 46, respectively.

Willowbrook lost a dual meet to Addison Trail on Saturday at Prairie Bluff Public Golf Club in Crest Hill. The Blazers beat the Warriors 171-177. Martens shot Willowbrook's low round on the par-36 course with a nine-hole score of 42. Hathaway fired a 43, while Rattana and Morser contributed scores of 45 and 47.

Guthrie has been playing golf for about two years. He took up an interest in the game after his father Joe took him to the driving range at The Village Links of Glen Ellyn. At about the same time he took up the game two years ago, Guthrie became a caddy at the Glen Oak Country Club in Glen Ellyn. His father was also a caddy at the same club.

"I love it," said Guthrie of caddying. "I find it fun to be around the game."

Guthrie witnessed a hole-in-one while caddying at Glen Oak earlier this year.

Willowbrook will play in the West Suburban Gold Conference Meet this week at Prairie Bluff Public Golf Club. The Warriors will play in next week's IHSA regional at The Links of Carillon in Plainfield.

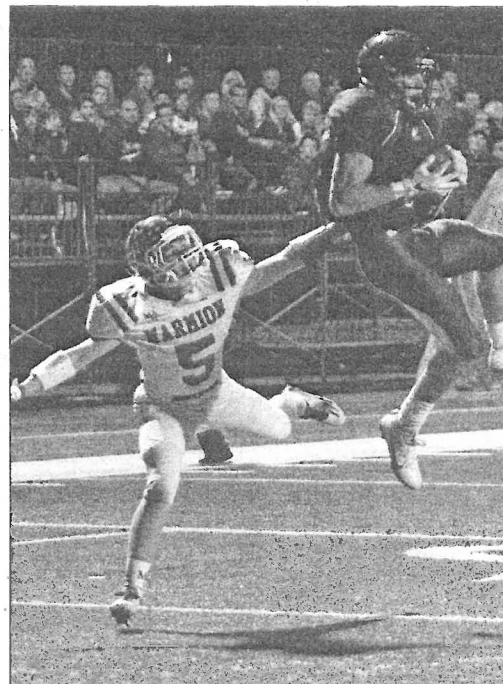

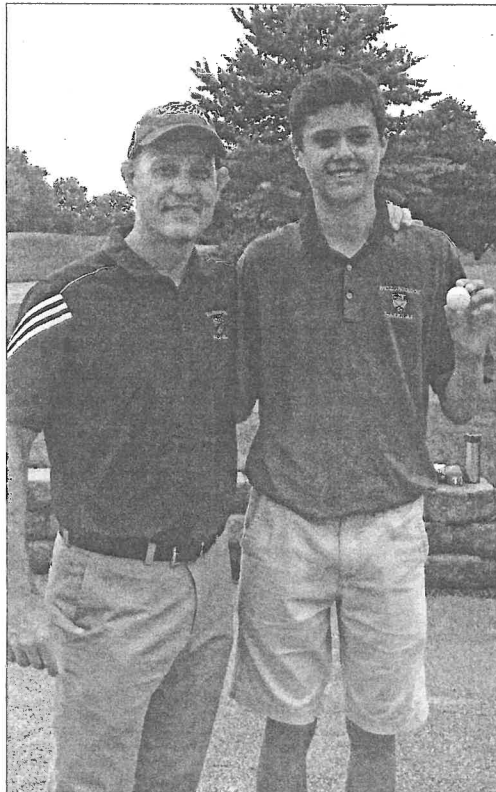
Marmion scored its only touchdown of the night later in the third quarter.

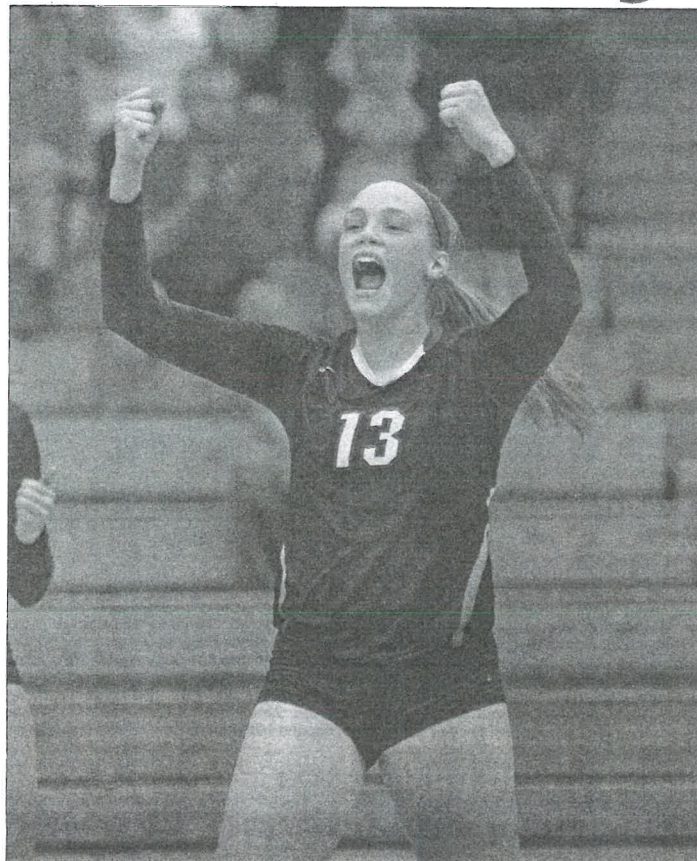

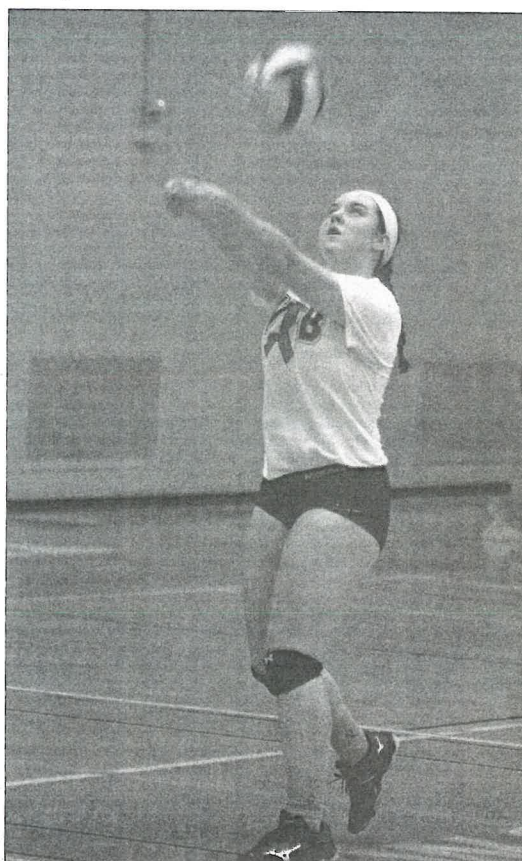

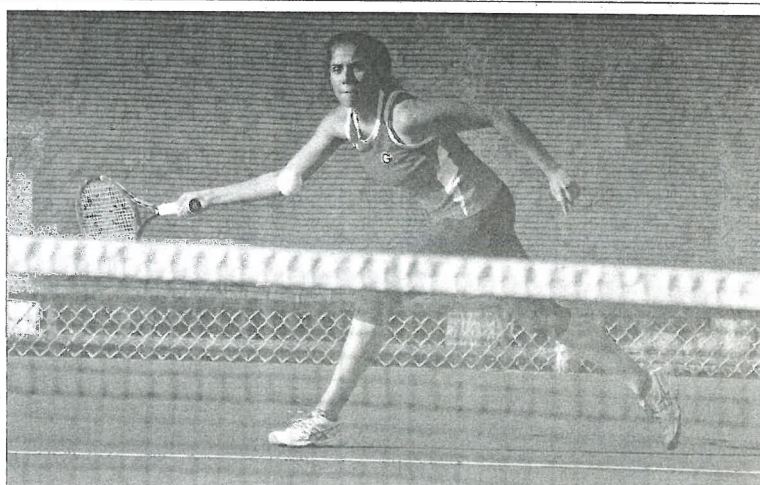
Warriors battle in Volley for the Cure

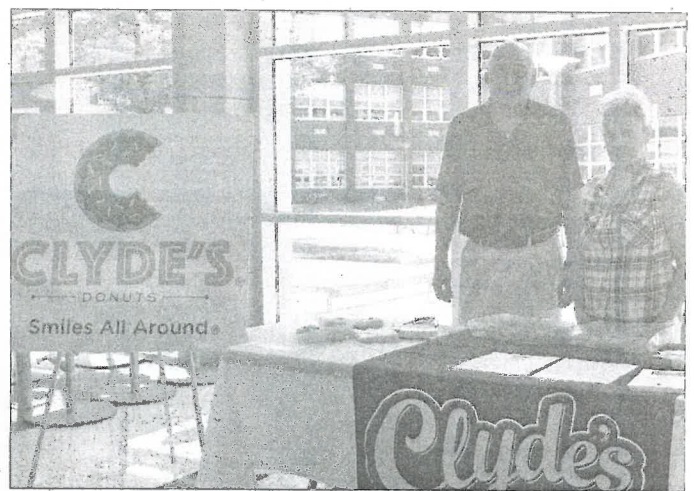

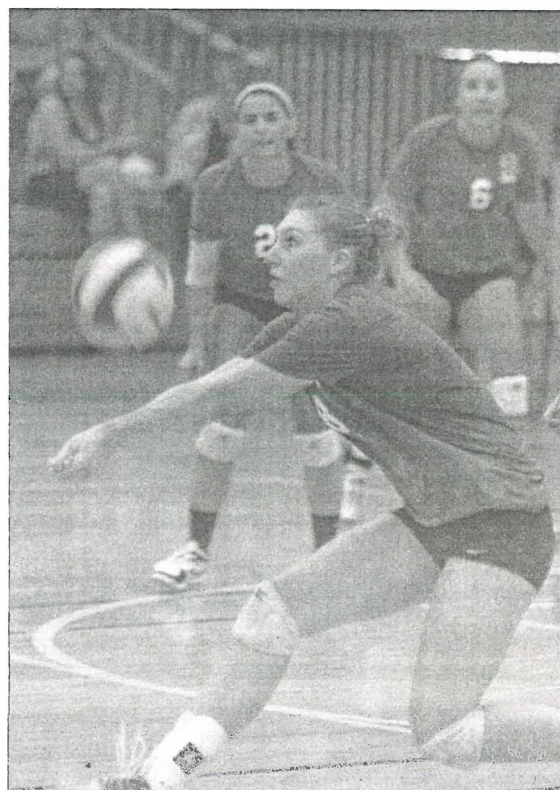
Willowbrook also competed in the Addison Trail "Ryder Cup" quad at Indian Lakes Golf Club's Highland course (par 36).

Willowbrook's Guthrie shoots hole in one at Addison Trail boys golf quad

Willowbrook sophomore golfer Joey Guthrie is now the owner of the sport's Holy Grail of milestones.

Guthrie shot a hole-in-one at the recent Addison Trail (Ryder Cup) quad held at Indian Lakes Golf Club's Highland course in Bloomingdale (par 36).

Guthrie recorded the ace on the course's par-3, 135-yard fourth hole. It was his first career hole in one.

"The wind was in my face. I hit an 8-iron and it took two bounces and rolled about a foot and then dropped," said Guthrie.

Guthrie had the pleasure of watching it go in the hole. "I saw it go in," he said.

"One of our opponents called it and said it had a chance of going in when I hit it and it did. I dropped my club and jumped and screamed. It was very cool."

Guthrie had an inkling he did well off the fourth tee. "Yeah, it felt great when I hit it," he said. "It was a nice

and smooth swing. I knew I would be pretty close to the pin, but I didn't expect it to go in."

Guthrie said he's been golfing for about 2 1/2 years. "I started going to the range with my dad and whacking balls around and enjoyed myself," he said. "I wanted to learn and develop my swing after that and I've been playing ever since. I've stuck with it."

Guthrie counts Village Links in Glen Ellyn as his off-season course when he's not playing with the Willowbrook team at Sugar Creek in Villa Park. Guthrie takes private lessons through Village Links.

"My consistency is better this year," he said. "Last year I would hit a couple good shots and a couple bad ones. This year I'm more even. My irons also are starting to get a lot better."

Guthrie counts his short game as the best part of his golf arsenal. "My short game on the green and around the game is strong," said Guthrie, who shot a season-low 87 for 18

holes earlier this season for Willowbrook in a meet at St. Andrews in West Chicago.

"I enjoy high-school golf," he said. "You get to play golf every day. It's a good time out there and it's a stress reliever."

Guthrie, who has a 3.25 grade-point average, is a three-sport athlete at Willowbrook, also competing in basketball and baseball.

"It kind of gets tough when it gets busy with homework," he explained. "I have to make sure I don't lollygag at home and make sure I get my work done and keep my grades up."

Guthrie has set his sights on finishing the season strong. Willowbrook competes in Class 3A regional play this week.

"I'm playing pretty well right now," he said late last week. "Hopefully I can perform well at regionals and possibly advance to sectionals."

Guthrie also wouldn't mind history repeating itself off the tee.

"I would love to get another hole in one," he said with a laugh.

Addison Trail's strong girls tennis season continues

Blazers reach pair of milestones in match against conference power Downers South

The hits keep coming in the Addison Trail girls tennis team's record-breaking season.

The Blazers got off to an 8-2 overall start in dual matches and 3-0 in West Suburban Conference Gold Division play before losing to perennial conference powerhouse Downers Grove South late last week.

However, Addison Trail reached a pair of milestones in the Downers South match. For the first time in coach Justin Hegner's 11 years at the school, an Addison Trail player won a match against a Downers Grove South player (Pa-

mela Kobeszko at No. 2 singles).

Also, the Addison Trail No. 1 doubles team of Jessica Bach and Gianna Sarli lost 4-6, 6-3, 6-4, becoming the first Blazers' doubles team to take a set off Downers South.

"In the past 11 years we had not won a match or set against Downers Grove South," said Hegner. "They usually are the powerhouse. This year we won a match and our first doubles took them to a tough three-set match. We had a couple other close matches as well. It's definitely the most competitive we have ever been with them in my 11 years of coaching."

Addison Trail upped its record

to 3-0 in conference with previous wins against Willowbrook (7-0) and Morton (5-2).

In the Willowbrook match, the Addison Trail No. 2 doubles team of Meryem Ahmed and Viany Ortiz played a three-hour and 10-minute match, winning 6-4, 4-6, 7-6 (7-3 tiebreak).

"They even had to finish in the dark at Willowbrook since the sun set at 7 p.m. and the match went until 7:30 p.m.," noted Hegner. "It was the best match of the year."

Hegner said one key difference this season is Addison Trail is holding its own when matches come down to the wire. "We are winning a lot of our close match-

es," he said. "If our girls have a chance to win they win. They also never give up even when they are down in a match."

Hegner said the team is hard at work improving the mental aspect of its game. "We know that tennis has a lot of mental ups and downs and we are trying to keep those downs to a minimum," he said.

Hegner also lauded the recent play of Bach and Sarli. "They have been doing very well and are our best mentally focused girls on the team," he said.

"This is only their second year playing tennis. They played volleyball before. And to be playing first doubles on the varsity tells

you how quickly they have learned over the last two years. They are taking strong teams to the edge and have beaten many teams that we have lost to in the past."

Hegner said the team is working hard at attaining even more success. "We have had the best season I have coached so far," he said. "In the past our best record at the end of the season was 7-6 and we already have passed that. We have been winning most of our close matches and have been mentally strong for the most part. If we can continue this we have a chance to have the best season in school history for the tennis team."

After a tough start to the 2015 season, the Fenton football team is settling in and showing plenty of signs of progress.

The Bison have won two of their last three games. After starting 0-2, Fenton defeated Guerin Prep (33-0) and Walther Christian (48-0) and lost 41-7 to Glenbard South in the Metro Suburban Conference Blue Division opener for both teams.

Sophomore quarterback Kyle Cacioppo also has drawn praise from Kos. "Kyle exceeded expectations the first four weeks," he said. "He's a natural at the position and he's a leader as evidenced by the seniors choosing him to be an honorary captain in the first week."

Cacioppo has had success throwing the ball to wide receiver Tyler Santagata. "He continues to show what he can do on the practice field and in games," said Kos of Santagata.

In addition to Santagata, Cacioppo

also throws to wide receivers Carlos and Nick Mercado.

Besides Butts, Fenton's line also has been bolstered by the play of center Danny Lucas. "He's done a great job of tackling the leadership role," said Kos. "He's a vocal leader and has done great anchoring our line."

Coroner: D-88 student died after choking in lunchroom

LOMBARD – DuPage County officials are investigating the death of a 15-year-old Willowbrook High School student.

At 12:16 p.m. Sept. 19, the Villa Park fire and police departments responded to an incident at Willowbrook High School for a student who was choking in the lunchroom.

The student was unresponsive as paramedics arrived and began life-saving protocol measures.

The 15-year-old was taken to Elmhurst Hospital but was pronounced dead at 1:09 p.m., according to a new release from the DuPage County Coroner's Office.

According to the coroner, the student had Down syndrome, but that doesn't appear to have any bearing on the student's death.

An autopsy was performed Sept. 20, which provided a preliminary indication that the victim may have choked on a piece of food.

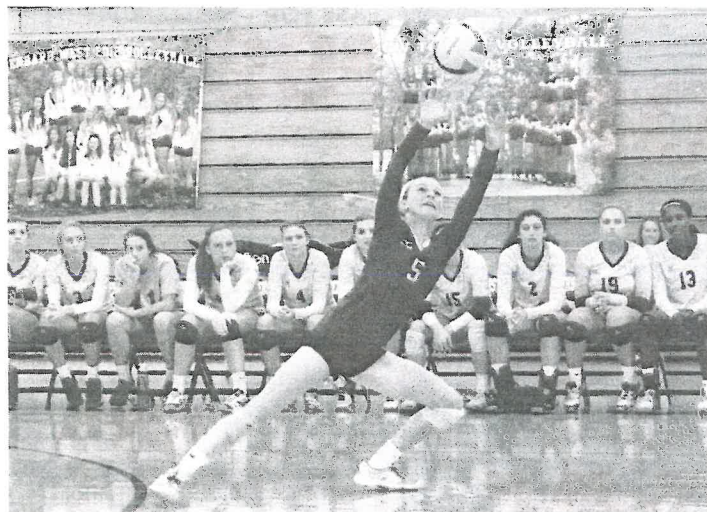
