

Warriors taste post-season success

The Willowbrook football program earned its first post-season victory in 26 years with Saturday's 34-13 IHSA Class 7A playoff win at Quincy. The Warriors trailed the Blue Devils 13-6 in the fourth quarter before scoring four touchdowns in the last four min-

utes of the game. Willowbrook, which improved its overall season record to 7-3, will meet Glenbrook North in this week's second-round playoff battle in Villa Park. The Warriors haven't hosted a playoff game since 1994.

Drop off Halloween pumpkins at Village Hall on Saturday

Villa Park residents are encouraged to drop off their Halloween pumpkins and jack-o-lanterns in the parking lot behind Villa Park Village Hall from 9 a.m. to noon on Saturday, Nov. 5. The village hall is located at 20 S. Ardmore Ave. All of the col-lected pumpkins will be transported

to commercial composting facilities and turned into rich soil nutrients. Candles and all decorations should be removed from pumpkins

should be removed from pumpkins brought to the collection.

Glen Ellyn-based School and Community Assistance for Recycling and Composting Education (SCARCE) will collect the pumpkins on Saturday. According to SCARCE, pumpkins are full of nutrients that are good for the soil.

SCARCE collected post-Hallows.

SCARCE collected post-Hallow-een pumpkins at three locations in 2014 and report diverting over nine tons of pumpkins from landfills. The program expanded to 12 locations in 2015 and collected more than 26 tons of pumpkins.

Vilia Park's unlimited fall leaf disposal continues throughout November

The Village of Villa Park's fall leaf collection program allows residents to dispose an unlimited number of Kraft paper bags of leaves without affixing any yard waste dispos-al stickers. The program is in effect during a seven-week period that began in October and ends the week of Nov. 28 to Dec. 2.

Brush must be tied in bundles no longer than 4 feet, no larger than 18 inches in diameter and weighing no more than 50 pounds. No limbs over 4 inches in diameter will be accept

Yard waste is limited to what is generated at the residence being serviced and must be placed out for pickup by 6 a.m.

Yard waste stickers are not re-

quired for the disposal of brush bundles. Since all brush and yard waste are transported to a compost-ing facility for processing, plastic bags should not be used. Residents should use only biodegradable twine

or string to bind brush.

It is unlawful to deposit yard waste of any kind into public streets. For more information, call the village's public works department at 630-834-8505.

Sen. Cullerton responds to College of DuPage audit

State Sen. Tom Cullerton (D-Villa Park) recently emphasized the importance of learning from past mistakes in regard to the results of the College of DuPage audit. "Though I am not surprised by what the audit reveals in terms of

past mistakes with regards to College of DuPage, I am hopeful that with the new leadership in place the commu-nity college will remain the top-tier educational institution it has always been," Tom Cullerton said. "We have implemented multiple reforms at the state level and President Rondeau and the current board of trustees have and the current obard of trustees have shown a commitment to reforming the failed practices of the past." Cullerton sponsored legislation that would curb administrative bloat

that led to scandals. The legislation included not allowing college administrators to abuse the pension system by claiming perks like a housing al-

wance as pensionable income.
"With the steps we took during the spring legislative session and the results of this audit, the College of DuPage can protect its students and the taxpayers from the past mistakes ever happening again," Cullerton

Late flurry lifts Willowbrook to its first playoff win in 26 years

Facing the end of its season and a five-hour ride back to Villa Park, the Willowbrook football team delivered a 28-point outburst in the closing minutes of the fourth quarter to overtake Quincy High School in Saturday's IHSA Class 7A first-round playoff

The scoring barrage carried Willowbrook to a 34-13 victory in Quincy. The come-from-behind win gave the Warriors their first post-season football victory since 1990, when they earned two wins (over Maine South and Highland Park) in the Class 5A level. Willowbrook, which improved its 2016 record to 7-3 with Saturday's triumph, will play its first home playoff game since 1994 (a 36-27 loss to St. Charles in a Class 6A battle) this week. The Warriors will meet Glenbrook North (9-1) in a second-round battle in Villa Park. The winner will advance to the Class 7A quarterfinals. The Spartans moved into the second round of the playoffs with a 17-7 win

The Warriors trailed the Blue Devils 13-6 with about four minutes, remaining in the game. Willowbrook cut Quincy's lead to 13-12 when junior Jack Jessen broke a touchdown run of about 50 yards. The Warriors attempted and failed a two-point conversion try that would have given them the lead.

Willowbrook took the lead when it scored a defensive touchdown with just under two minutes to play. Jessen and senior Khalif Copeland converged on a Quincy ball carrier and forced a fumble. Junior Kevon Dobbins caught the loose ball out of the air and raced about 20 yards into the end. zone for the go-ahead score. Willow-brook pushed its lead to 20-13 on a successful two-point conversion pass from senior quarterback M.J. Ranieri to senior Jonathan Kelso.

The Warriors piled on two more scores in the final two minutes. Moments after Quincy turned the ball over on downs. Jessen-who ran for about 150 yards in the game-turned

Willowbrook football team wins first playoff game in 16 years

The long road trip for the Willowbrook football team was well worth the effort.

The Warriors made the trek down to Quincy High School and came away with a come-from-behind 34-13 victoryover the Blue Devils in the first round of the Class 7A state playoffs.

Willowbrook won the game when it scored 28 unanswered points in the fourth quarter. Kevon Dobbins erased a 13-12 deficit when he returned a fumble recovery for a touchdown. Jack Jessen followed with a rushing touchdown and Jacob Entwhistle returned an interception for a touchdown.

The game was 0-0 after the first quarter and Willowbrook took a 6-3 lead into halftime via a Jon Kelso touchdown. A Quincy field goal tied the game at 6-6 heading into the fourth quarter and Quincy went up 13-6 before Willowbrook mounted its comeback that started with the first of Jessen's two rushing touchdowns.

Willowbrook is the No. 23 seed in the 32-team 7A bracket, while Quincy was the No. 10 seed.

The win was Willowbrook's first in the playoffs

since the 1990 season when it defeated Maine South in Class 5A action, snapping a string of 10 straight playoff appearances without a win. It's the sixth time in school history Willowbrook has won an openinground playoff game.

The win against Quincy means Willowbrook will come home either Friday or Saturday to face No. 7 seed Glenbrook North (9-1). It's Willowbrook's first home playoff game since 1994.
