### Village issues clarification about waste collection tags and bin stickers

The Village of Villa Park issued a statement last week regarding its yard waste tags. "The most recent flier issued about 'Yard Waste Collection Dos and Don'ts' mentioned 'prepaid Yellow Yard Waste Tag(s)' and 'Free stickers...available at Public Works,' said the statement.

"The Village wishes to clarify that these two types of labels are not interchangeable," the statement continued.

The village's release added that, per village ordinance, leaves and yard waste, regardless of container, must be labeled with prepaid Yellow Yard Waste Tags. You can purchase these at various locations throughout Villa Park, including Ace Hardware, Pioneer Garden and Feed, and Village Hall.

"If you would like to dispose of your yard waste in a bin you already own, complimentary stickers to mark containers designated for yard waste are available at Public Works," noted the village's statement.

Free leaf collection operates this fall from Oct. 16 to Dec. 8. Residents can dispose an unlimited number of Kraft paper bags of leaves with no need for a yellow label. All other yard waste, however, will require a yellow label.

### Free leaf pickup begins next week

The Village of Villa Park announced last week that free leaf collection will begin on Oct. 16—one week earlier than originally announced.

"Though free leaf pickup was originally scheduled to begin on Oct. 23, the village will now be able to extend this service an extra week," according to a statement released by the village. The collection will continue through Dec. 8.

Residents can dispose of an unlimited number of Kraft paper bags of leaves without having to affix yellow yard waste disposal stickers, which are required during the rest of the year.

Brush must be tied in bundles no longer than four feet and not larger than 18 inches in diameter. No limbs over four inches will be accepted. Make sure to have brush and leaves ready at the curb before 6 a.m. on collection day.

# Conroy co-sponsors bill against credit freeze fees

In response to the recent Equifax data breach, state Rep. Deb Conroy, D-Villa Park, is co-sponsoring a bill that will prevent credit agencies from charging consumers fees to freeze their credit.

"Consumers who trusted the security of Equifax should not foot the bill for freezing their accounts due to the carelessness of a large corporation," said Conroy. "Personal information of millions of Illinoisans was put at risk, and consumers need to be able to take steps to protect their identities and sensitive information."

Equifax announced it had suffered a massive data breach of sensitive consumer information from May to July of this year, impacting as many as 143 million Americans. In Illinois, the breach is believed to have jeopardized the personal and financial information of more than 5.4 million residents.

In order to protect oneself from identity theft, Attorney General Lisa Madigan is encouraging residents to consider placing a freeze on their

credit and sign up for free credit reports. House Bill 4095 would require agencies like Equifax to provide this service for free.

"The massive leak of information by Equifax puts millions of Illinois residents at risk and should be taken very seriously. The Attorney General's Office has been working diligently to educate people on the steps they need to take to protect their personal information," said Conroy. "I encourage all residents to seek out the resources and information put out by the Attorney General's Office."

## Warriors roll to 6-1 by crushing Morton 56-6 Fifth straight win locks up a playoff berth

The Willowbrook football team improved to 6-1 overall and 4-0 in West Suburban Gold Conference play with Friday's 56-6 rout of Morton in Cicero. The Warriors, who have won their last five games, scored four first-quarter touchdowns to take a 28-0 lead over the Mustangs (1-6 overall, 1-3 in the conference) through 12 minutes. Willowbrook added two more touchdowns in the second quarter to build its lead to 42-0 by halftime.

The victory secured a second straight IHSA playoff berth for the Warriors, who advanced to the Class 7A quarterfinals in 2016.

Willowbrook will finish its regular season with two conference home games, starting with this Friday's contest against Proviso East (0-7 overall, 0-4 in the conference). The Warriors will battle Downers Grove South in an Oct. 20 meeting in Villa Park. If the Warriors can win both of their last two regular-season games, they will win the outright conference championship with an unblemished 6-0 record.

### Rams lose non-conference game to Jacobs

One week after earning its first victory of the 2017 season, Glenbard

East suffered a 35-7 loss to Jacobs in Friday's non-conference game in Lombard. The loss dropped the Rams' overall record to 1-6.

The visiting Golden Eagles held a 21-0 lead at halftime. Following a scoreless third quarter, Jacobs (which improved its overall record to 5-2) scored on a 75-yard touchdown run with about 10 minutes left in the fourth quarter. Glenbard East then scored its lone touchdown of the night on a 25-yard pass from junior quarterback Bret Bushka to junior Jeremy Johnson. Senior Jared Rech made the extra-point kick to cut the Golden Eagles' lead to 28-7.

Jacobs fumbled the ensuing kickoff and senior Kevin Saxon of the Rams recovered the ball. Glenbard East's offense proceeded to advance the ball inside the Golden Eagles' 20-yard line, but the drive ended on an incomplete fourth-down pass.

Jacobs scored its final touchdown of the night with about one minute to play.

The Rams' season continues with this Friday's Upstate Eight Valley Conference game at West Chicago (2-5 overall, 1-3 in the conference). Glenbard East will finish its season with an Oct. 20 home conference

game against Bartlett.  
**Montini pounds DePaul to move to 5-2**

The Broncos improved their 2017 record to 5-2 with Friday's 56-0 wipeout of DePaul College Prep in Lombard. Playing in its final home game of the regular season, Montini scored three touchdowns in each of

the first two quarters against DePaul, which fell to 2-5.

## Warriors crush Proviso East to move within one win of a conference title

*A home win this Friday would give the Warriors their first conference crown since 1982*

The Willowbrook football team earned its sixth straight win by pounding Proviso East 57-12 in Friday's West Suburban Gold Conference game in Villa Park.

The Warriors, who held a 44-0 halftime lead over the winless Pirates, improved to 7-1 overall and 5-0 in conference play with one game left in the regular season. If Willowbrook beats Downers Grove South (4-4 overall, 4-1 conference) in this Friday's conference game in Villa Park, it will finish alone atop the conference standings. The Warriors have never won or shared the West Suburban Gold Conference football championship. The team has finished second in the conference standings in four of the last five seasons. The Willowbrook program last won a conference football title 35 years ago, when it won the Des Plaines Valley League crown in 1982.

"I think we were a little bit sloppy," said Willowbrook coach Nick Hildreth after Friday's victory. "We're always prepping for who we're playing, but we're concentrating on getting better and being sharp. It wasn't all bad. We did some things well, but we have to do better."

The Warriors drove 62 yards for a touchdown on their first drive of the night. Senior quarterback John Taylor scored on a 10-yard run with 10:40 left in the first quarter. Senior Betty-Ann Garrett, who made seven of eight extra-point attempts on the night, made the ensuing kick to give Willowbrook a 7-0 lead.

The Warriors needed only one play to score on their next drive. Senior Chris Diaz busted a 66-yard

touchdown run down the sideline to extend Willowbrook's lead to 13-0 with 8:48 left in the first quarter. Later in the period, Taylor connected with junior Scott Tumilty on a 9-yard touchdown pass. The Warriors held a 21-0 lead by the end of the first quarter.

The lead grew to 23-0 when the Pirates (0-8 overall, 0-5 in the conference) committed a holding pen-

alty in the end zone, which resulted in a safety. Proviso East then punted to the Warriors, who soon scored their fourth touchdown of the night. A 27-yard pass from Taylor to senior Sikander Zafar moved the ball to the Pirates' 2-yard-line.

Senior Jack Jessen carried the ball over the goal line two plays later. Senior Christian Washington scored the Warriors' next touchdown on a



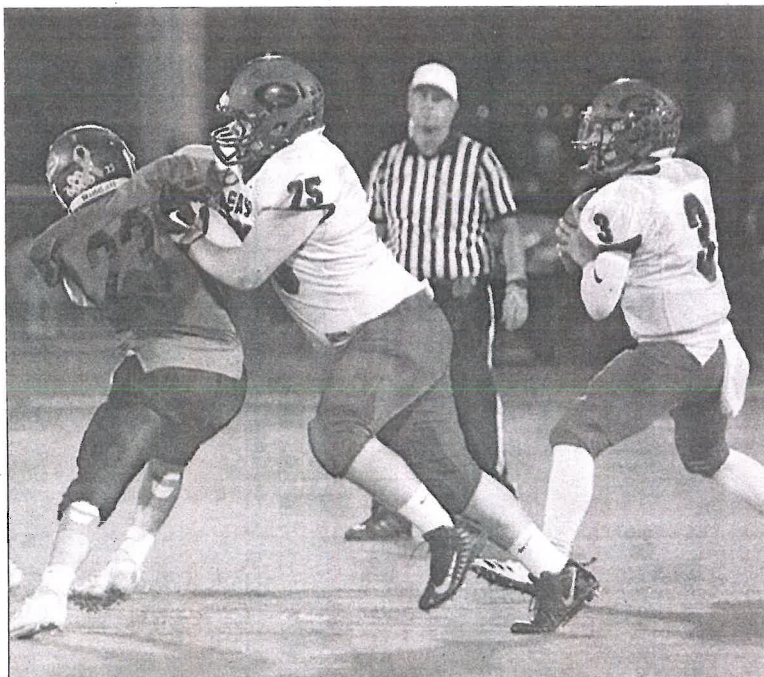
2-yard run with less than three minutes to play in the first half. Taylor fired a touchdown pass of about 50 yards to senior Martique Barksdale with about one minute left in the half. That touchdown increased the lead to 43-0 and set up a running clock for the entire second half.

Junior D'Onte Gholston returned a kickoff 80 yards for a touchdown to account for one of the Warriors' second-half scores. Junior Franshun Jordan scored Willowbrook's eighth and final touchdown on an interception return.

In addition to giving the Warriors sole possession of the conference title, a win over Downers Grove South this Friday would improve the team's seeding in the upcoming playoffs.

"We really haven't talked about it much," said Hildreth of the team's quest for a conference title. "Everything will kind of take care of itself. Our approach is the same every week. We're trying to get better."

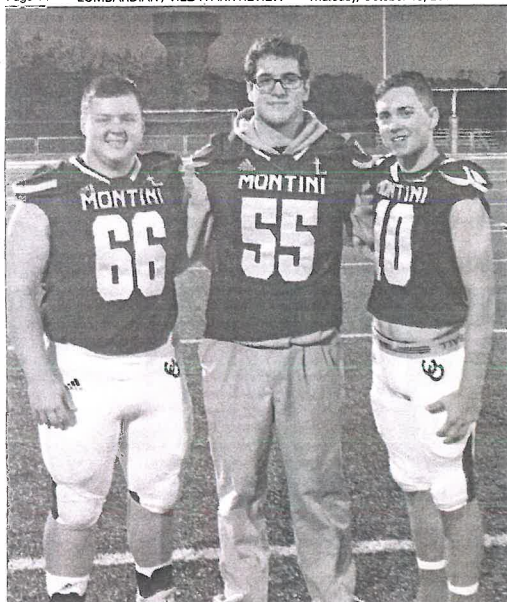

### Glenbard East earns its second win, outscoring West Chicago 43-22

The Rams earned their second win in three games when they traveled to West Chicago and beat the Wildcats 43-22 in Friday's Upstate Eight Valley Conference contest. Glenbard East improved to 2-6 overall and 2-2 in conference action. The Rams will complete the 2017 season with this Friday's Upstate Eight Valley home game against Bartlett (also 2-6 overall and 2-2 in the conference).

Glenbard East trailed West Chicago (2-6, 1-4) 16-7 after one quarter, but the Rams proceeded to score 36 straight points to take a 43-16 lead. Glenbard East seized a 29-16 edge by halftime.

Junior quarterback Bret Bushka completed nine of 17 pass attempts for 235 yards and three touchdowns. Bushka also ran 13 times for 68 yards and a pair of scores.

Senior receiver Kenny Adams made five catches for 159 yards and two touchdowns. Adams scored the game's opening touchdown on an 85-yard pass play in the first quarter. He scored the Rams' next touchdown on a 46-yard reception from Bushka in the second quarter.

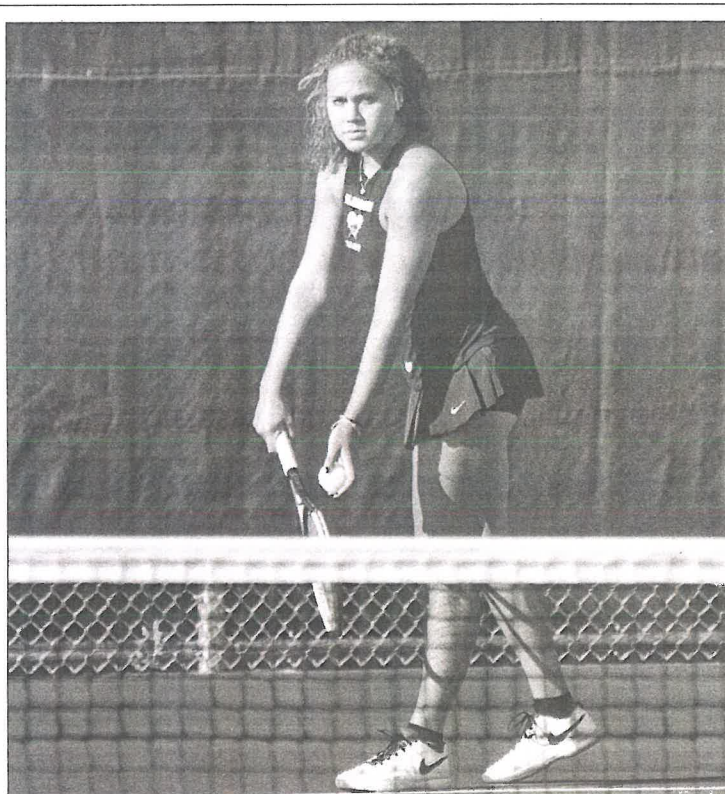
Bushka delivered a short touchdown run in the second quarter. He also fired a 17-yard scoring strike to junior Jeremy Johnson. The Rams' offense continued to produce points in the second half. Johnson ran 31 yards for a touchdown in the third quarter. Bushka scored the team's final touchdown on a 16-yard run in the fourth quarter.

Senior Jack Oberli matched Bushka as the team's rushing leader; both Rams ran for 68 yards. Johnson gained 46 yards on five carries.

The Wildcats held a 16-15 lead and had the ball inside the Rams' 10-yard line in the second quarter, but Glenbard East senior nose tackle KeShawn Spencer forced a fumble. Senior defensive end Patrick Lyons recovered the fumble. The Rams then put together a drive that ended with Bushka's short touchdown run.

Junior linebacker Jack Baka of the Rams forced a fumble on West Chicago's first possession of the second half.

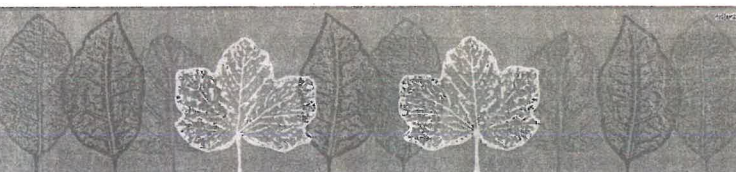
Senior linebacker Patrick Leahy recovered the loose ball at midfield. Glenbard East then drove for a score—Johnson's 17-yard reception from Bushka.

"The library will contact you when your item is ready for pick-up. To request an item, or put one on hold: Please call 630-627-0316, visit a reference desk at the library or use our online library account.

"We are constantly adding to our collection, but let us know if there's something specific you'd like to see. You can use our online form at <http://www.helenplum.org/suggest-title>."

## District 88 provides information about its 2017-18 budget

**Editor's note:** A District 88 news release published recently included the following column from Ed Hoster, the district's chief financial officer.

At District 88, we are committed to maintaining a stable and fiscally responsible budget.

During its Sept. 25 meeting, the District 88 Board of Education adopted the district's annual fiscal-year budget for 2017-18, after a public hearing on the budget took place. The district's operating budget plan includes estimated revenue of \$66,516,284 and expenditures of \$67,993,952.

We are projecting the fund balance reserves as of June 2018 will be \$46,015,888 after the one-time transfer of \$1,335,000 from the Working Cash Fund for capital projects, replacement buses and the copier lease transfer of \$46,335.

Therefore, adjusting for the transfers, the projected operating budget deficit is \$1,189,003, which is an improvement from the June tentative budget estimated deficit of \$1,725,212. The budget planning process has become increasingly more challenging, given the recently settled state budget stalemate and the impact of the economy on local conditions.

Despite state and local financial challenges, we are committed to continuing to exercise strong management control of the expenditures throughout the year to stay within the budget plan. We will continue to actively work toward achieving a balanced budget through intentional efforts with the Board of Education and staff in the coming year.

## Cullerton bill to offer public education on opioid abuse

DuPage parents will soon have easily found educational information to prevent heroin and opioid addiction, thanks to Villa Park Democrat, state Sen. Tom Cullerton.

Cullerton's measure, House Bill 3161, which will require the Department of Human Services to create and maintain a website to educate the public on heroin and prescription opioid abuse, was signed into law recently.

"We need to equip every single person who touches the life of a young person with the necessary resources to combat the heroin epidemic," Cullerton said. "This is a simple step the state can take to make sure DuPage parents have a place to turn to help their children kick this deadly addiction."

The website will include items such as the warning signs of heroin and prescription opioid addiction, helpful hints for parents on how to discuss the dangers of these addictions with their children, available treatment options and services, and other related information.

This new law comes in light of a request made by the federal government to DHS. Without the passage of House Bill 3161 the state risks losing federal funds to fight substance addiction.

The DuPage County Coroner's Office's reports showed a total of 78 opiate-related deaths in 2016, a 78 percent increase from last year.

"We need to make sure people know there is help out there," Cullerton said. "We need to make sure those suffering from opioid addiction and their loved ones know where to find it."

Cullerton is urging DuPage County residents to give his Villa Park Office a call at 630-903-6662 with any question regarding where to receive help fighting opioid addiction.

House Bill 3161 passed the Senate and House with bipartisan support. The new law will go into effect on Jan. 1, 2018.

## Free leaf collection begins Oct. 23 and ends Dec. 1

Lombard's annual six-week free leaf pick-up for residents begins Monday, Oct. 23 and will end Friday, Dec. 1.

During this time, an unlimited amount of paper bags containing only leaves may be placed at a resident's own curbside, on their normal Waste Management collection day, without need of stickers.

Yard waste stickers are required on any cans and also for nonresidential properties. Stickers cost \$1.97 each and are available at local stores and Village Hall. Cans and bags filled with grass, twigs, branches and plant materials must have stickers.

Yard waste stickers are required on any cans and also for nonresidential properties. Lombard's free leaf collection program schedule was adjusted in 2016 to occur later in the year, in order to better accommodate leaf fall and available yard work time over the Thanksgiving Holiday. Waste Management collects

the leaves and delivers them to local farms for composting.

Properly bundled brush does not require a sticker at any time of the year. Each bundle of brush must be securely tied and not exceed 6 feet in length, 18 inches in diameter, nor 50 pounds. Individual limbs and branches must be less than 6 inches in diameter.

Leaves must not be blown or raked into the streets since they can block the storm drains and also raise phosphorus levels in ponds and streams, thereby contributing to algae growth in warm weather. The same is true for grass clippings placed on streets.

Mulching leaves and grass into lawns provides useful nutrients with no harm off-site.

DuPage County recently took part in the John Noel Public Transit Conference, which featured speakers from the Contra Costa County, Calif. GoMentum Program and Argonne National Laboratory Transportation Research Group.

Contra Costa County GoMentum Leader Jack Hall told attendees about county partnerships with private and state, federal and local public entities for the development of innovative transportation systems and autonomous transit.

"This is a very exciting program that is a model of collaboration for all of us to carefully consider," DuPage County Public Transit Committee Chairman Pete DiCianni said. "Here in DuPage, we are fortunate to work closely with Argonne National Laboratory as we examine ways to connect transit and technology to provide solutions for commuters, and maintain DuPage County's standing as a competitive entity

in the Midwest's transit systems."

Argonne National Laboratory's Director of Transportation Research Ann Schlenker discussed her group's efforts regarding Smart Cities and the deployment of technology that will allow transportation and transit agencies to operate more efficiently and to better inform their users.

The theme of this year's conference was Smart Cities/Smart Counties. During his opening remarks, RTA Chairman Kirk Dillard pointed to several areas in which the RTA was pivotal in bringing new technology to improve mass transit for customers.

"We need a robust communications network along roads," Dillard said. "That can include Transit Signal Priority, which is able to sync stoplights with bus routes to provide riders with a faster and more efficient travel experience, especially when a bus is running late."

The John Noel Conference annually brings together leaders of the regional public transit providers to share past successes, describe the evolution of public transit services and learn about pertinent topics pertaining to public transit services in DuPage County.

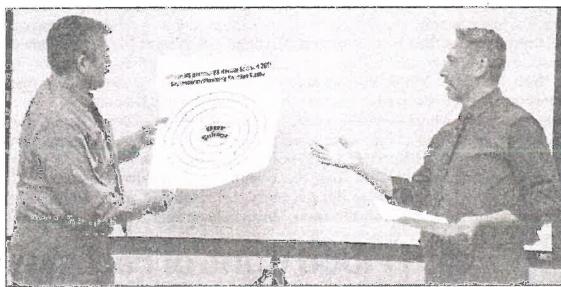


# School districts 4, 45, 48 and 88 meet as Joint Board

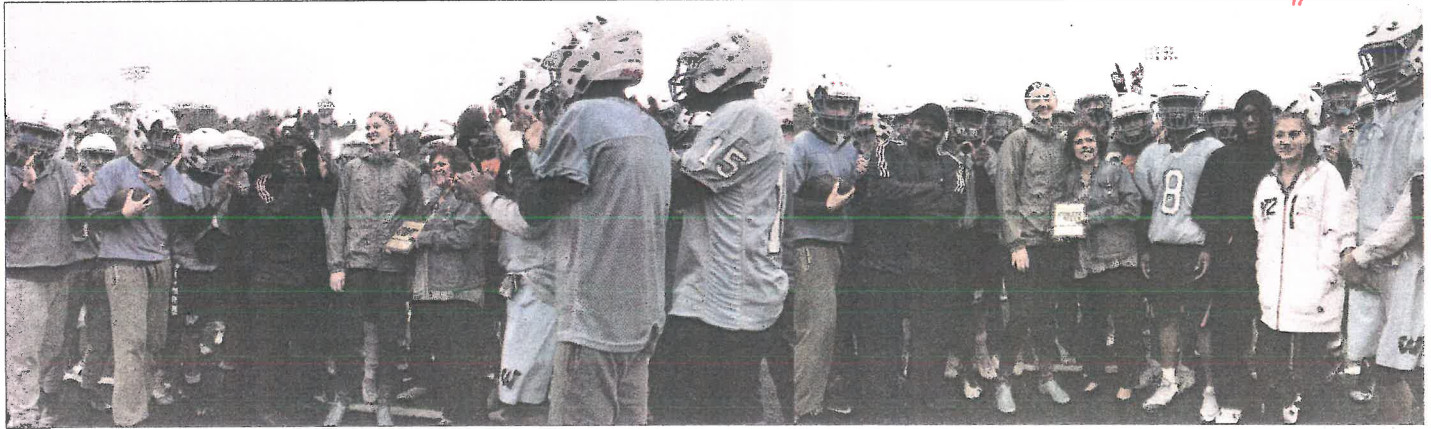

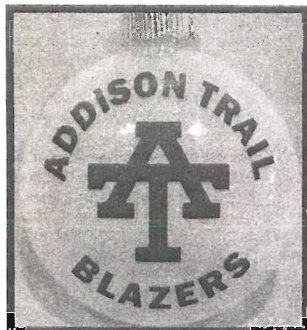

## D'Ambrose rushes for 316 yards and four scores in Addison Trail football win

Addison Trail boys soccer team beats Mt. Carmel

The Addison Trail football team scored a 34-7 victory over Morton in a West Suburban Conference Gold Division game in Addison.

The win broke a five-game losing streak and put the Blazers at 3-5 overall and 1-4 in WSC Gold play.

Addison Trail finishes out the 2017 season in Maywood Saturday at 1 p.m., against Proviso East.

The Blazers led 7-0 after the first quarter and 14-0 at halftime. Addison Trail extended the lead to 27-7 after three quarters.

Addison Trail running back Nick D'Ambrose ran 21 times for 316 yards and scored four touchdowns in the win. He had a 73-yard long run and averaged 15.0 yards per carry.

Dennis Ionikov caught three passes for 13 yards and AJ Parnell caught one pass for 13 yards.

Addison Trail had 365 yards of total offense.

D'Ambrose also returned a kickoff 41 yards. Christian Cici returned a punt 43 yards for a touchdown and Vince Daudelin had a 16-yard punt return.

On the season, D'Ambrose has rushed for 888 yards on 114 carries and has six rushing touchdowns and seven total touchdowns. He's only played in five games this season. It was his third game of the year rushing for 200 or more yards. He had 224 yards on 24 carries to go with two touchdowns against Glenbard South and also ran for 224 yards on 32 carries against Glenbard West.

### Addison Trail boys soccer

The Addison Trail boys soccer team has provided plenty of excitement of late.

The Blazers recently beat Mt. Carmel 1-0 in a non-conference game on senior night at Addison Trail. Mt. Carmel was ranked No. 18 in the Chicago area at the time.

Addison Trail also lost 2-1 to perennial state power Morton in a West Suburban Conference Gold Division game in Berywn.

"That was a great game at their place," said Addison Trail coach Ryan Dini.

The Blazers also recently tied Hinsdale Central 2-2 in a WSC crossover game. Addison Trail scored with 14 seconds left in the game to tie the score.

"Our team really is playing well of late and is looking forward to the playoffs," said Dini.

The Blazers have been bolstered by the play of Alexis DelaPaz, along with goalies Jean Avila and Sam Sandoval. "Alexis is playing really well," said Dini. "He has really emerged over the past two weeks with his ball control and distributing to teammates. Both goalies have stepped up their games at the right time of the season. It has been great to see both of them improve over the past month."

Junior midfielder Melvin Mora was leading the team in scoring through late last week with six goals and four assists. Senior midfielder Luis Saucedo had three goals and four assists, while senior forward Christian Garcia had three goals and three assists.

The coach also lauded the play of senior forward Osbaldo Murillo. "He scored against Hinsdale Central," Dini noted. "He has good height and speed and we moved him from defense to offense about a week ago. He has given us another dimension up top and is good at 50/50 balls."

Dini has been pleased with the team's offensive

makeover of late. "The offense has improved over the past week with our guys getting to scoring spots on the field so we can have some success," he said. "We are creating more opportunities with our speed and angle runs by our forwards. I also have moved some of our better defenders up at times to get more numbers up toward the penalty box. Our set plays have improved as well so we are taking advantage of corner kicks and throw-ins near the top of the box."

The Blazers have been sound on defense throughout the season, Dini noted. "Our defense has been really solid all year long. With playing some of the best teams in the state, we are holding our own. I play six defenders and of the six, only one is a senior. The other four are juniors and one is a sophomore. This is great news for next year's team because most of them will be back."

Through the first 20 games of the season, the Blazers have allowed more than two goals only six times and have four shutouts. Avila has a 1.42 goals-against average, while Sandoval, a junior, has a 2.38 GAA.

"Both goalies bring a little something different to the game so our plan is to play both during the play-offs by giving them each a half," said Dini. "They really haven't separated themselves from each other. We are lucky to have them both."

Addison Trail, through late last week, had played six teams currently ranked in the top 20.

"Our team is believing we can beat anyone we play," said Dini. "Although our record is 1-4-1 against those teams, we have been really competitive in those games besides one. It feels like every game we play is against a strong team. That is getting us ready for the state tournament. We beat a good Mt. Carmel team that I think will make it to at least sectionals, so that was a really good confidence boost. I also think our communication on the field has improved and has allowed for us to be more organized."

Due to the foul weather that hit the area this past Saturday, Addison Trail's first playoff game against Elk Grove was moved to this past Monday. The winner was to face York on Tuesday at Glenbard East in regional semifinal action.

## Mello hired as Fenton's new girls basketball coach

No stranger to Bison athletics over the years

Fenton has turned to a longtime familiar face for its new girls basketball coach.

Dave Mello, a longtime multi-sport coach at the Bensenville high school, is the new girls basketball coach at Fenton. He is the school's third coach since the end of last season, replacing longtime coach Tim Anderson and Megan Andrews, who was hired to replace Anderson.

Mello stepped down from his position as head girls basketball coach at Bartlett High School to take the Fenton position. Mello is a physical education teacher at Bartlett.

"I had been in the Fenton program for 15 seasons prior to going to Bartlett," said Mello. "When the Fenton job came open for the second time in six months, it was a sign that it was meant to be. If it was anywhere else but Fenton I wouldn't have considered leaving the Bartlett job."

Mello also is currently the varsity assistant girls volleyball coach and the school's head softball coach. He's been a coach at Fenton since 1995.

"I have a lot invested in Fenton athletics," he said. "I want to do what I can to build the girls basketball program back up to where it should be."

Mello said it was tough leaving the Bartlett job. "I teach there so that made it even more difficult of a decision," he said. "But I had to do what I felt my calling was right now."

Mello has taught PE and driver's education at Bartlett since 2002. Mello did his student-teaching at Fenton.

"I didn't get right into teaching at that point. I worked for a company in Elk Grove first," he said.

Mello noted he started coaching boys soccer at Fenton in the fall of 1995. He also coached girls basketball and softball at now defunct Driscoll High School in Addison. He made it over to the girls volleyball and softball programs at Fenton around the turn of the century. He became the head softball coach at Fenton in 2008 and was co-head coach of the girls volleyball team with Josh Payton for two years. He's been with the Fenton girls volleyball varsity team since 2011.

One thing Mello is excited about is this year's senior players on the Fenton girls basketball team.

"Those seniors were my last freshmen group at Fenton," he said.

Mello is chomping at the bit to get going and elevate the Bison program.

"We know we play in a tough conference with some private schools, but there is no reason we can't continue to get better and compete," he said.

"Our number-one goal is to establish a culture here and attract kids who want to be involved with Fenton girls basketball. In our initial meeting, we had 52 girls who had signed up for basketball or expressed an interest. That's a great start to have that many. We had some T-shirts made up because we want to get that logo out in the school. Some of the girls wore them the next day and there were some staff members who said there was more talk about Fenton girls basketball that one day than there has been the previous four or five years put together. We're going to get out there and compete and see where it takes us. We're going to establish this program and get it on track. We'll worry about the conference and the regional down the road."

Mello again stressed the importance of being at Fenton. "Since I started coaching there in 1995, it's a place that holds a lot of importance for me. I have a lot of blue and orange in my closet," he said. "I do some driver's ed behind the wheel for them in summer, coach the different sports there and do the summer camps. For me it's like my second home. My family always comes first, but Fenton is like that second home. I've received nothing but great support from the administration and teachers and there has been great buy-in from the athletes there."

Mello feels success in the program can be achieved. "You hear people sometimes say Fenton never wins. Why can't we?" he asked. "We've had success in softball. We lost 1-0 last year in the regional title game to Whitney Young and had the bases loaded in the top of the seventh against them. That's a perfect example. We need to get these girls to believe that we can compete and we will. We want the days of, 'It's just Fenton again,' to be over."

Mello said former Fenton all-state softball player Tara Lawson will be his varsity assistant coach.

"We're ready to go," he said. "I can't wait for practice to start."

## Illinois coal producers praise Trump administration's planned rollback of the Clean Power Plan

ILLINOIS NEWS NETWORK  
Illinois coal producers are breathing a sigh of relief following the announcement of the Trump administration's planned rollback of the Clean Power Plan.

The Obama-era rules were an effort

to limit carbon emissions from coal-fired plants. Legal challenges have prevented the regulations from ever actually taking effect.

"The Clean Power Plan going away means that power plants that could not comply with the air emissions limits are going to be kept online," said Phil Gonet, president of the Illinois Coal Association. "We'll be able to provide them with coal to provide reliable energy."

Uncertainty about the regulations helped contribute to a recent wave of shutdowns of coal-fired plants. More than 400 have closed their doors in the past six years nationwide. Gonet says the whole idea never made much sense.

"Even Gina McCarthy, the former administrator of the EPA, admitted if the United States implemented the Clean Power Plan, it would have an impact on global [carbon dioxide] emissions of less than 1%," Gonet said. "Our point was, it's going to cost billions of dollars in more costly power from renewables or wherever to replace coal and it would have a negligible impact on emissions worldwide. Why are we doing this?"

The EPA estimates that repealing the Clean Power Plan could lead to up to \$33 billion dollars in avoided compliance costs in 2030. And Gonet says the increased regulatory certainty would mean a brighter future for Illinois coal.

"I see coal [in Illinois] that is easy to extract," Gonet said. "The coal mines are very productive, in terms of tons per man hour produced. Our operators know how to get the product to the end market. And in a shrinking marketplace, the low-cost producer is going to prevail."

Total coal production in Illinois is expected to be up about 12% in 2017, to 50 million tons. Illinois supports about 3,300 jobs in the coal industry, down from about 4,400 just three years ago, and a high of 10,000 back in 1990.

Gonet says the rollback is a shot in the arm for the industry but admits it's not a cure-all.

"The [rollback of] the Clean Power Plan, while we welcome it, is not going to bring those plants back," Gonet said, "but it's going to stop the bleeding and stop the further reduction in coal being used."

**Welge: I hear you're one of the longest drivers in the state. True?**

**Leahy:** Freshman year I wasn't that big of a kid, but I really started working out. I hit the gym, got bigger and it helped. When you're hitting balls off the tee over 300 yards [he averages around 313] it makes those long par fours and par fives a lot shorter.

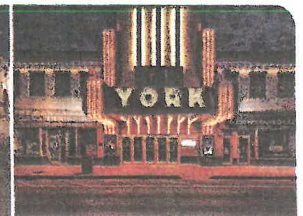

# Hinsdale South fair to present post-high school options for students with disabilities

**W**hile most high school seniors have a variety of choices for the next step in their lives, the choices for students with disabilities may be more limited or more complex.

To help those students and their parents be aware of the range of choices, a post-secondary options fair for students with disabilities will be held from 6:15 p.m. to 8:30 p.m. on Oct. 26 in the fieldhouse at [Hinsdale South High School](#), 7401 S. [Clarendon Hills Road](#), [Darien](#).

The effort, a partnership by Hinsdale High School District 86, Lyons Township High School, Neuqua Valley High School, Oak Park and River Forest High School and a dozen other districts in the western suburbs, will include representatives of more than 65 colleges, and community and state agencies.



More and more colleges are offering programs for students with disabilities, said Tammy Prentiss, District 86 assistant superintendent of student services.

The costs range from a fee per credit hour to more than \$20,000 per semester for a residential program.

College of DuPage, for example, started a two-year program this fall for people with intellectual and developmental disabilities, called Coach, to prepare them for employment. It's designed for people age 22 and older who are mildly or moderately disabled, said Susan Landers, the program manager.

For the first year, students attend reading, writing, math and computer classes three days a week. The classes, which are structured specifically for the students' abilities, are not for credit.

In the third semester, students explore their career interests by job shadowing on the DuPage campus. The fourth semester, students work on campus in an unpaid internship. The tuition is \$2,499 per semester.

The college developed the new program because "people were really looking for a pathway to transition to employment and a college experience," Landers said.

Elmhurst College has the Elmhurst Learning and Success Academy, a four-year certificate program for young adults, ages 18-28, with intellectual, developmental, physical and/or sensory disabilities. The academy includes academics, career exploration, internships and social skills classes.

Full-time tuition at the academy this year is \$15,913 per semester. Part-time tuition is \$835 per credit hour.

National Louis University has had a college program for students with multiple learning and developmental disabilities for more than 30 years in Chicago, said Iva Kolarov, executive director of the program called Path to Academics, Community and Employment.

"A lot of our students are on the autism spectrum," Kolarov said.

As of last fall, the program was extended from a two-year program to three years.

"We redesigned all our curriculum. We found our students really needed that third year to get the skills they needed to find employment," Kolarov said.

Students age 18 to 28 take classes that lead to a certificate in fields, such as retail, child care and hospital operations service. They then work as interns at [Rush University Medical Center](#), DePaul's Loop campus and Shedd Aquarium and other places.

"The options keep growing," Kolarov said. "The demand is there."

The students live in dormitories or apartments in the Lincoln Park area and can participate in weekend social activities, such as attending sporting and cultural events in the city.



The cost is about \$43,000 a year, including housing.

Other organizations at the fair, such as Options for College Success, provide support services for students with disabilities attending Chicago area colleges. The nonprofit organization based in Evanston creates an individual plan for each student, said Christine Anderson, executive director of Options.

"We help them choose a schedule and match the student with a teacher. We can help with time management and life skills," such as navigating a college campus and riding public transportation, Anderson said.

Beginning at 6:45 p.m. on Oct. 26, there will be ongoing 15-minute presentations in three different rooms at Hinsdale South.

"Everyone who will be there has expertise and knows the ins and outs of the services they have for students with disabilities," Prentiss said.

# Panthers celebrate playoff win

A lot of hard work has taken place in recent years as Glenbard North works to build up its girls volleyball program. Monday night at Downers Grove the Panthers got to enjoy a nice reward.

The Panthers opened the Class 4A regionals with a solid 25-19, 25-22 defeat of Willowbrook to earn a shot at top-seeded Downers Grove North in Tuesday's regional semifinals.

No. 16 Glenbard North (12-24) used solid defense to jump ahead 19-9 and take the opener without ever trailing. The second set was another story; they had to erase a 13-7 lead by the Warriors before completing the sweep and claiming the program's first postseason win in years.

"This is the first postseason

victory we've had in five-plus years," Panthers coach Anne Bremner said. "The girls know how hard we've been working. We've been taking baby steps all along the way, and the girls want it so bad."

It may have been a case of nerves that played a role in Glenbard North's struggles early in the second set, but the up-and-comers regrouped well and got back on track.

"Sometimes your own goals get in the way of achieving your goals. They were real nervous. They wanted it so bad so we needed to just calm them down," said Bremner, who called two timeouts early in the second set. "They deserve it. We've been close in years past. Last year we were right there but we didn't have the edge that we had tonight."

Sophomore Maddie Meyers showed off just how much her game has improved this fall, finishing with a match-high 9 kills for a Glenbard North team that also got 6 kills apiece from Anastasia Brown and Maddie Vegrzyn.

"We played exceptional. We really stepped it up in that game and we had really good defense," Meyers said. "We jelled really well and I think it was a great team effort. We have a young team this year but we've been stepping up ... inch by inch it's been paying off."

With a 14-8 lead in the opener, Glenbard North pulled away after a trio of kills from Meyers, who displayed some impressive leaping ability, and another winner from Brenda Nguyen.

The combination of a balanced offensive attack and strong defense carried Glenbard North to victory. Sophomore

libero Alyssa Torres had 10 digs and Meyers added 9 digs to her all-around effort.

"We knew Willowbrook was going to be a small team that's going to tip a lot and we adjusted our defense," Bremner said. "The girls did a nice job. I felt like we picked up almost everything."

For Willowbrook (11-24), which had beaten the Panthers in three sets at the start of the season, Taylor Balsitis had 5 kills and Katelyn McCann had 7 digs.

"Our girls worked hard and pushed themselves to get every point, they just came up short unfortunately," Warriors coach Irene Mason said. "The defense was great the last few points. In these final games I've been seeing that out of them more and more. Just that defensive intensity that we've been looking for this whole season."

# Blazers shake off nerves, Proviso W.

into the playoffs like this, but we'll see," Hildreth said. "We need to keep playing well."

### Overcoming adversity:

The hallmark of defending Class 3A champion IC Catholic Prep remains taking things one day at a time.

"That's something that's kind of been with us since the beginning," Knights coach Bill Krefft said. "We're not worried about anyone else, we're not thinking about anyone else. We're worried about IC and winning the next practice."

ICCP (8-1) got a sharp dose of reality when returning all-state quarterback and four-year starter Luke Ricobene went down with a season-ending knee injury in Week 2 against St. Laurence, the Knights' sole loss.

After catching their breath Krefft, offensive coordinator Tony Navigato, defensive coordinator Roger Kelley and fellow ICCP gurus such as Matt Bowen shifted gears. Particularly since the injury to Ricobene, a defensive back in key situations, affected several positions.

"When Luke went down it took six or seven people to take his place," Krefft said.

Fortunately for the Knights, and similar to typically late-November programs

such as Glenbard West and Montini, extra weeks of practice provided valuable experience to backups and scout team players.

Khalil Saunders quickly went out injured in a brief stint at quarterback before tight end, receiver and backup quarterback C.J. West took over the zone-read offense.

Completing 64 percent of his passes for 19 touchdowns to only 2 interceptions, West leads an offense that has scored 460 points. Linebackers Kemon Reese, Kevin Cooke and Khali Saunders are the top tacklers on a defense that's allowed 91 points. The Knights' 41-point average margin of victory leads all Class 3A teams entering Friday's playoff opener against Watseka. They'll look no further ahead than that.

"The resilience and adaptability is much greater than teams we've had in the past," Krefft said. "I see this team as one that's competing to win a round-one playoff game."

### Upset minded:

Downers Grove North has been in this position before. Many times, in fact.

So when the Trojans (5-4) saw they were seeded 31st in the Class 7A field, they didn't shy away from a first-round meeting against No. 2 Normal Community (9-0). They welcomed the challenge.

"Every year we play better as the season goes along," said Trojans coach John Wander. "I think it's a matter of hitting our stride late in the year and just getting better at what we do."

Downers North entered the playoffs at 5-4 five times since 2008, and three times the Trojans upset a much higher seed.

In 2008 Downers North beat second-seeded Wheaton Warrenville South and No. 3 Proviso East. The Trojans topped No. 1 Batavia and No. 5 Thornton in 2012, and the next year beat No. 1 Whitney Young and No. 5 WW South.

Twice the Trojans fell in the first round to heavily favored teams: No. 3 Mt. Carmel in 2006 and No. 3 Libertyville in 2015. Both teams wound up finishing second in the state.

The intense competitiveness stems from Downers North's play in the West Suburban Silver. Facing the annual gauntlet of Glenbard West, Lyons Twp., Hinsdale Central and Oak Park takes its toll, but the Trojans are battle-tested if they survive for the playoffs.

A comeback win over Oak Park in Week 6 turned out to be the victory that pushed Downers North into the postseason.

"Our conference is as competitive top to bottom as any

other conference in the state," Wander said. "These kids have gone up against teams like Glenbard West, so they don't fear anyone."

### Prepped:

Naperville Central (7-2) faces a familiar foe in the opening round of the Class 8A playoffs. As the 13th seed, the Redhawks take on former DuPage Valley Conference member and 20th seed West Aurora (7-2).

Redhawks coach Mike Stine sees fragments of current DVC teams in this Blackhawks group. Thanks to that experience, he feels his team will be better prepared heading into Friday's matchup.

"The DVC prepares you for the playoffs because you see a little bit of everything," Stine said. "It definitely helps this time of year."

Stine sees Lake Park's athleticism, Wheaton North's ability to control the ball and Neuqua Valley's 3-5-3 defense all in West Aurora's game plan.

After a year away from the playoffs, the Redhawks are eager to put their DVC experience back to good use.

"It's nice to be back in the playoffs," Stine said. "We feel like we're ready."

### Tunnel vision:

Standing at 3-4 with two DuPage Valley Conference

foes remaining, one of them defending conference co-champion Neuqua Valley, makes for a rough road to a playoff berth.

Glenbard North kept plugging away.

"We never said it's do or die," Panthers coach Ryan Wilkens said. "We just stayed focused on what we can control."

That meant the same formula Glenbard North (5-4) has used for most of its 21 playoff appearances — a pounding ground game, rugged defense, an athletic secondary and enough passing to keep teams honest.

The combination of a huge game on both sides of the ball by tailback-linebacker Jayleen Fitzpatrick, sophomore Angelo Cusumano's 100 yards rushing and 2 interceptions by another sophomore, Kobie Jamison, punched the Panthers' ticket into the postseason with a 24-14 defeat of Neuqua Valley. Seeded 29th in the Class 7A playoffs, now all the pressure is on No. 4 Batavia.

"We never really talked about it much, never harped on it," Wilkens said of the playoff hunt. "We talked about executing, about kids doing their jobs."

something to do with it. The Trojans awakened once Isaiah Whitaker took a cross from Martens and shot off the crossbar, but not enough to keep it from caroming into the back of the net on a bounce.

"We've been a little slow to start the last few games, but once we get our feet underneath us, we go," Trojans coach Stephen Fernandes said. "We created a few dangerous chances for ourselves in the first half, not many, but we finished the ones we had."

# Warriors figure out Raiders

There was a collective groan from the Wheaton Academy fans when senior Grayson Harris needed assistance to limp off the field during Wednesday's Class 2A boys soccer sectional semifinal game against Glenbard South.

Harris had already scored twice and assisted on another goal as the Warriors were in command of the Raiders with a 3-0 lead and only 9:34 remaining.

Wheaton Academy closed out a 3-0 victory and earned a berth in Friday's championship game against Timothy Christian, a team the Warriors beat 9-1 on Aug. 24.

As for Harris' injury, it was only a cramp.

"It was nothing more than a double calf cramp, so I'm fine," he said. "It just took us awhile to figure out their strategy to hold 10 behind the ball. Once we calmed down we were able to break them down better and look for the open guy or maneuver through them."

Wheaton Academy (21-4-0), which beat Glenbard South 5-0 on Sept. 26, was held scoreless in the first half.

The Warriors finally broke through with 33:15 remaining when Luke Holwerda followed in Harris' shot for his 30th goal of the season.

"They really defended well in the first half and kind of stifled our attack," Holwerda said. "So at halftime our coaches motivated us and got

us to move more and it really worked."

Holwerda continues to make big plays.

Jack Kilgallon assisted Harris with 22:42 remaining to give the Warriors some breathing room while Harris' unassisted goal with 14:07 left all but sealed the victory.

"Once we got that first goal it opened things up because they needed to score to get back in it, so we had more space to push," Harris said. "With multiple scorers we're not scared to play it to whoever is open because we know they'll finish."

Increased movement without the ball proved to be the

big difference in the second half.

"I thought we had a lot of dynamic movement off the ball which we talked about at halftime," Brooke said. "They had a successful strategy in the first half and we were too stagnant so we started making diagonal and overlapping runs."

"We had some breakdowns and they finished in the second half," Raiders coach Adam Szyzsko said. "That's a quality side and they're going to take advantage of any breakdowns and they can score in bunches."

The loss ended one of the best seasons in program history at Glenbard South (12-8-1), which won a regional for just the second time.

"Our guys had a nice little run this year," Szyzsko said. "It was a good performance and we've got a lot of people coming back, so hopefully it's good tidings as we go into the Upstate Eight."
