During its Monday, Sept. 14 meeting, the District 88 Board of Education approved the administration's recommendation to complete the Internet Essentials Agreement with Comcast for a 12-month term. Comcast is one

Here are frequently-asked questions: What is the Internet Essentials Partnership Program?

Through this program, school districts find appropriate vendors to provide internet service at no cost to low-income students.

Who is eligible to participate in the program?

Households may be eligible for Internet Essentials if they:

• Qualify for the National School

· Live in an area where Comcast Internet Service is available

· Have not had Comcast Internet in the last 90 days

How do I apply for the program?

· Eligible families will receive details and a promo code from Addison Trail or Willowbrook.

District 88 will pay for the service. All or some of the costs will be reimbursed by the ROE. Funding will be provided from the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act.

A message from District 88 Superintendent Dr. Scott Helton

District 88 Superintendent offered the following information in his weekly column in the District

88 newsletter:

"Dealing with the coronavirus disease 2019 (COVID-19) pandemic isn't easy. We are all doing our best to overcome hardships we've never faced before and with which we never thought we would be confronted.

"We know Remote Learning is challenging, and we know it isn't ideal, But I want to reiterate that this is a health crisis, and we must make decisions based on what's best for our students, staff, families and community members to keep them safe.

"It is our responsibility to protect the health and well-being of

our pupils, as well as the peers, staff members, parents/guardians and grandparents with whom they

interact.

To help accomplish this, we are following data and guidance presented by medical experts. The most recent DuPage County COVID-19 School Metrics do not support transitioning to a hybrid or in-person environment at this time.

For the week of Aug. 30 to Sept.

The Illinois Department of Public Health (IDPH) moved DuPage County from a "minimal" county-level risk to a "moderate" county-level risk.

• In the category of New Cases per 100,000 per Week, DuPage County increased from 75 per

100,000 to 89 per 100,000.

• In the category of Weekly Case Count Trend, DuPage County increased by 15.6 percent.

· In the category of Weekly Youth Case Count Trend (younger than 20 years old), DuPage County increased by 43.5 percent.

· DuPage County also increased in the Neighboring/Regional Indi

"These numbers and trends are concerning, which is why maintaining Remote Learning is the best course of action at this time. I know it's difficult. I'm the father of three children - one of whom might miss out on his senior year of wrestling at Southern Illinois University Edwardsville. I also was a teacher and coached football, wrestling and track, and I understand this is extremely upsetting and not what any of us want. But I assure you we will continue to connect with and care for students and provide a robust curriculum. I also assure you we are prepared to move to a hybrid/ in-person environment when the data and guidance support that decision. "We want your children back in our buildings - but more importantly, we want them safe and healthy.

"We hear your concerns, and we see your frustrations. I would like to remind you we have been meeting monthly with parents/ guardians through our Transition/ Reopening Committee since June 30, and we will meet throughout the school year to work together to overcome this adverse situation. The next meeting will begin at 6:30 p.m. on Oct. 13, and I invite all parents/guardians to join this group. Those who are interested in attending can contact me at shelton@dupage88.net or 630-530-
