STAGE 2

REMOTE PLUS

A block schedule (80 minutes) is proposed for Monday, Tuesday, Thursday, Friday and morning instruction would remain remote. Afternoon resource time may be remote or in person depending on student need. See the following pages for important details.

STAGE 3

BLENDED REMOTE/HYBRID

Blended instruction would begin bringing groups of students on campus for in-person instruction. See the following pages for important details.

The plans below are based on the DuPage County COVID-19 IDPH School Metrics Guidance Document (shown at right – click on the image to view a high-resolution version)

In the table below, different learning models have been incorporated under the three corresponding IDPH-defined community transmission levels, as outlined in IDPH Adaptive Pause guidance and County Level COVID-19 Risk Metrics.

1. Additionally, DuPage County Health Department (DCHD) will be working closely with schools to monitor absenteeism, disease activity, and other indicators and trends to further inform learning model considerations.
2. For current DuPage County-level metrics on COVID-19 community transmission and the current level of Community Transmission see the DCHD COVID-19 dashboard at: www.dupagehealth.org/covid19data. This dashboard will be updated each Friday.
3. DuPage County's Level of COVID-19 Community Transmission is determined by the highest category in which a single metric is met or exceeded. For example, if one metric is met or exceeded in the "Substantial Community Transmission" category, DuPage County will be at that level.
4. When considering a shift to more in-person learning, all metrics should be under the identified thresholds for a given level for at least 2 consecutive weeks. For example, all metrics in the "Minimal Community Transmission" category should be below the identified thresholds for at least 2 consecutive weeks before DuPage County will be listed in the "Minimal Community Transmission" level.

- **STAGE 1 REMOTE** - (Approved to begin the year, with status to be reviewed at the October 5th BOE meeting). The success of remote instruction will be the most critical component of our instructional planning as all of our instructional stages during this pandemic will contain a robust remote instructional program. During this remote period, all instruction and resource support is remote with the following exception: in-person, intermittent instruction/interventions, as determined necessary by the IEP team, may be held for special student populations (LINK 1, DLP, TRANSITION) that are unable to access remote learning independently. These opportunities may be scheduled in advance in consultation with the department head in the identified programs based on student need and teacher input. Additionally, students needing support accessing remote learning (prioritizing SPED, ELL, and 504) may access learning centers on campus while connecting with his/her remote instruction.
- **Learning Centers** - Students with significant barriers to remote learning be approved to access learning centers on campus. Identification, registration, and transportation for approved students will be coordinator by the building administration. Students will be assigned to assigned locations and must follow all student expectations for in-person learning. Students will be given headphones to prevent distractions. Please contact the building principals for more information.

- In-person and remote after school tutoring programs may be open on a limited basis for students needing extra support. These would be tutoring positions that could be staffed with teacher assistants with the proper credentials.

- **STAGE 2 REMOTE PLUS** - All staff will be encouraged to work from the building with the exception of those approved for remote work accommodation. Teachers are encouraged to be on campus only for their assigned instructional periods except for Resource.
- The block schedule (80 minutes) remains for Monday, Tuesday, Thursday, and Friday.
- Instruction will remain remote with the exception of the Transition, DLP, Link 1, BRC, ELL 1/Newcomer populations, and any other self-contained program identified by the department head and administration. Instructional staff and related service staff assigned to these programs will be required to work on campus with the exceptions of those approved for remote work accommodations. Additionally, teachers have the option to invite individual students or small groups of students for in-person instruction, intervention, social emotional supports, and/or related services on a very limited basis with department head and administrative approval (i.e., Department Heads may propose some in person learning opportunities to the administration for approval). Priority should be given to those experiences that cannot be replicated online and to students who are not successful in remote learning.
- Learning centers will be continued in each school to include students identified as needing in-person support to access remote coursework.
- Behind the Wheel instruction will resume following all IDPH recommendations.

- **STAGE 2 REMOTE PLUS**

- Transportation to school will be provided in two waves, before the first block and second block periods. Transportation home will be provided after the third block and after the fourth block.
- Students choosing to stay remote will have the option to stay fully remote.
- Afternoon resource time remains remote for all students, teachers, and teacher aides.
- Limited sports and activities may resume on a case by case basis provided that all capacity limits and IDPH requirements are met, and the athletics follow IHSA seasons.
- Tutoring will be available in both schools from 3:30 to 5:00 (PROGRAM TIMES TBD) each day. Tutoring options will be available both in-person (with capacity limits set at seven students/adult) and online. In person and remote positions will be staffed separately.
- Transportation will be provided for tutoring following all social distancing requirements.

- **STAGE 3 HYBRID** - All learning opportunities authorized in the Remote Plus phase may continue into the HYBRID phase. Additionally, each D88 student may attend school two days every two weeks and participate in classes online the other days. Students will be on campus for their classes only. Students do not need to report for their Remote Study period unless seeking assistance in the learning centers. Transportation to school will be provided before the first and second block periods. Transportation home will be provided after the third block and after the fourth block.
- Students choosing to stay remote will have the option to stay fully remote.
- Afternoon resource time remains remote for all students, teachers, and teacher aides.
- Limited sports and activities may resume on a case-by-case basis provided that all capacity limits and IDPH requirements are met, and the athletics follow IHSA seasons.
- Tutoring will be available in both schools from 3:30 to 5:00 (PROGRAM TIMES TBD) each day. Tutoring options will be available both in-person and online.
- Transportation will be provided to school for tutoring following all social distancing requirements.
