# **Credit Card Payment Summary**

The Board reviewed the district's credit card use report for February 2013, as outlined in Board Policy 4:55, Use of Credit and Procurement Cards.

#### Education Focus Items for March 11, 2013

Educational Focus items for the March 11 Board meeting will include the recognition of two 88's Best students, program changes and dropped courses for next school year, and student exchange participation.

## **ELL Audit Report Update**

The ISBE's Division of English Language Learners (ELL) conducted a "monitoring visit" of our ELL programs in each building which included classroom observations, staff and parent interviews, policy and curriculum review, and student file review. We received "no major findings" and instead had several "accolades."

# <u>Technology Update - District Website</u>

Aaron Lenaghan, Director of Technology, Teaching and Learning gave a presentation on the updates to our current district website including: interactive calendars, video integration and individualized department websites.

# <u>Update on General State Aid, Proposed Cuts</u>

Dr. Helton and Mr. Martin gave an overview on the General State Aid (GSA). This year's state budget had a GSA proration of 89%. Governor Quinn's proposed budget calls for a 7% reduction in GSA to 82%. Each 1% reduction is equal to \$33,411.

# **Board Election and Seating of Elected Board Members**

Dr. Helton stated that the consolidated election is scheduled for April 9, 2013. District 88 has three candidates for three seats. Incumbent board members Donna Craft Cain, Thomas Edmier and James (Jay) Irvin are seeking re-election.

Once the ballots are cast, the school board must hold its organizational meeting no later than 28 days after the consolidated election. Further, new board members cannot be seated until after the official canvass of the results by the county election authority. The deadline for the canvass is not until 21 days after the election. Therefore, the effective window period to hold all school board organizational meetings this year begins no earlier than Tuesday, April 30, and ends no later than Tuesday, May 7.

Dr. Helton stated that since our regular board meeting is April 29th, the Board will have to schedule a special meeting for the "organizational meeting." That date is tentatively scheduled for May 2, 2013 at 6:00 p.m.
